ABSTRACT

Grid connectivity for 1X250kW Wind Plant at Anakkaramettu Road, Parathodu Village, Idukki District- Application submitted by M/s Greenland Paper Mills Ltd.-Sanctioned-Orders issued.

ORDER

The Chief Engineer (Distribution Central), as per the letter read as (6th) above has forwarded the connectivity application submitted by M/s Greenland Paper Mills Ltd. towards establishing plant of capacity 1X250kW for Captive use. Alongwith the application, the requisite fee of Rs.35,400 /-(Application Fee Rs.30,000/-+18% GST) was remitted by the applicant through RTGS to the Office of the Chief Engineer,(Distribution Central),Ernakulam.

Earlier, M/s.Ramakkalmedu Power Pvt Ltd had submitted an application for connectivity for their proposed 2MW (8x250kW) wind power project at Nedumkandam, to the Chief Engineer(Distribution Central). The proposal was approved as per BO read as (2nd) above and sanction was accorded to the Chief Engineer (Distribution Central) to collect supervision charges as applicable and proceed with the application for connectivity. Accordingly M/s.Ramakkalmedu Power Pvt Ltd had remitted Rs.3,62,600/to the account of the Chief Engineer, (Distribution Central).

The technical approval was given by the ANERT to M/s. Ramakkalmedu Power Pvt Ltd as per paper read as 1st above for erecting eight Wind energy

Generators(WEGs) (8x250kW) on CPP mode. Subsequently M/s.Ramakkalmedu Power Pvt Ltd sold the developed sites to the below mentioned investor companies for implementing the projects.

Subsequently, the companies have obtained transfer of technical approval to their individual names from ANERT. As per the BO read as 3rd above it was sanctioned to proceed with the connectivity of the three above mentioned firms by Chief Engineer (Distribution Central) and to authorize the Chief Engineer, Transmission South to execute Open Access Agreement and to authorize the Chief Engineer (Commercial & Tariff) to execute the banking agreement.

M/s.Ramakkalmedu Power Pvt Ltd had sold two numbers of Wind Turbine Generators to M/s CV Renewables Pvt Ltd. and M/s Greenland Paper Mills Ltd has purchased land of one number of 250kW WEG from M/s CV Renewables Pvt Ltd. As per order read as 4th above, ANERT has transferred the Technical Approval of one WTG to M/s Greenland Paper Mills Ltd.

As per the technical approval, M/s Greenland Paper Mills Ltd submitted application for connectivity to the Chief Engineer(Distribution Central), of wind plant of capacity 1X250kW in CPP mode.

Regarding the proposed consumption of generated energy the applicant has furnished the following details:

As per letter read as 5th above, M/s Greenland Paper Mills Ltd has stated that they will be consuming the generated electricity for their own captive use by executing open access agreement with KSEBL.

The matter was placed before the Full Time Directors as per note read as 7th above. Having considered the matter in detail, the Full Time Directors in its meeting held on 05.05.2023 resolved to authorize the Chief Engineer (Distribution Central) to proceed with the connectivity of wind plant of capacity 1X250kW at Anakkaramettu Road, Parathodu Village, Idukki District by M/s. Greenland Paper Mills Ltd in CPP mode as per the prevailing regulations.

Further resolved to authorize the Chief Engineer, Transmission (South) to execute an open access agreement with M/s. Greenland Paper Mills Ltd.

Further resolved to authorize the Chief Engineer, (Commercial & Tariff) to execute a banking agreement with M/s. Greenland Paper Mills Ltd, as in B.O.(FTD) No.869/2022 KSEB / CE(REES)/Wind- RPPL/2015-16 dated 28.10.2022.
