ORDER

The 7th Monitoring Committee Meeting of Ministry of Power (MoP) for RDSS, a Government of India flagship program held on 15.03.2022 has approved the proposal of KSEBL for the implementation of SCADA project under RDSS scheme. As per the SCADA proposal prepared in line with the guidelines of the scheme issued by the MoP, KSEBL has proposed SCADA/DMS system in Kollam, Thrissur and Kannur (Group A towns) for advanced Distribution Management system and Basic SCADA system in 53 Towns (Municipalities-Group B) with Zonal SCADA Control Centres at Kollam, Kottayam, Ernakulam, Malappuram and Kannur. The upgradation of the existing three SCADA/DMS towns are proposed in Thiruvananthapuram, Ernakulam and Kozhikode (Group U). The proposal include implementation of SCADA in Cochin Port Authority(CoPA) and Thrissur Corporation Electricity Department (TCED) area. The total amount of the approved DPR is Rs. 534.15 Cr. including PMA (project management Agency) Cost.

As a first phase, the implementation of SCADA DMS in 3 towns has been sanctioned. KSEBL in line with the PFC guidelines have selected PMA, M/s WAPCOS Ltd. The PFC during the SBD review meeting has directed to move forward with the tendering of Group A & B towns together. Based on the modified

SBD furnished by PFC, the customized RfP was floated as per tender read as 4th above, for Group A&B towns together. The Group U Town's tender will be floated separately as recommended by PFC. As per the direction issued by PFC, Corrigendum has been issued regarding the issual of LoA in two phases to the successful bidder for group A & Group B towns separately.

In this context, the Chief Engineer (IT,CR&CAPs), as per note read as 5th above, has recommended to constitute the Pre- Qualification / Bid evaluation committee and Technical committee for processing of Tenders and for the implementation of RDSS SCADA Project.

Having considered the matter in detail, the Full Time Directors in its meeting held on 20.04.2023 resolved to accord sanction to constitute the Pre-qualification/ Bid Evaluation Committee and Technical Committee towards the implementation of SCADA project under RDSS in KSEBL as shown below:
