ORDER

The Chief Engineer, Distribution South Region, as per Note read as 5th above, reported that the Transformer repair Workshop and the TMR store attached to TMR Division, Pallom, are in need of urgent replacement of the very old and unserviceable Forklift, used for loading/ unloading and transportation of faulty/ repaired Transformers and CT-PT's within the TMR. The Forklift which is presently being used at TMR Division, Pallom was procured in 2009 and it requires frequent repairs, due to ageing. This affects the daily works of the Division very adversely.

The estimate prepared for a new Forklift with specifications [Diesel Forklift-3 TON Capacity Fitted with Tripple Mast of 4.5M Lift Height, Automatic Transmission, Solid Tyres, Fork Length 1000mm (min)], comes to Rs.10,20,000/- plus 18% GST. The all inclusive cost of the Forklift will be Rs.12,03,600/- (Rupees Twelve Lakh Three Thousand and Six Hundred Only).

The matter was placed before the Full Time Directors as per the note read as 6th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 26.11.2022, resolved to accord sanction for the procurement of a Forklift with the specifications [Diesel Forklift-3 TON Capacity Fitted with Tripple Mast of 4.5M Lift Height, Automatic Transmission, Solid Tyres, Fork Length 1000mm (min)], for an all inclusive estimated amount of Rs.12,03,600/- (Rupees Twelve Lakh Three Thousand and Six Hundred Only).

Further resolved to authorise the Deputy Chief Engineer, Electrical Circle, Kottayam to purchase the Forklift for TMR, Division, Pallom, by observing all formalities. The expense on account of this purchase be met from the budget provision for capital expenditure for TMR Division, Pallom, for the year 2022-23.
