ORDER

The Deputy Chief Engineer, Electrical Circle, Thiruvananthapuram as per the letter read as 1st above, informed that sanction had been accorded to an estimate amounting to ₹2,05,82,429/- (Rupees Two Crore Five Lakh Eighty two Thousand Four Hundred and Twenty nine only) for replacing the existing VCBs with RMUs, providing 11 kV ring fencing and replacing LT distribution system with LT ABC for standardization of LT electrical network of KINFRA International Apparel Parks Ltd. at Menamkulam under Electrical Section Kazhakkoottam. The work includes pole erection work for LT ABC, drawing LT ABC on turnkey basis, providing ring main and replacing existing old Vacuum Circuit Breakers with Ring Main Units on turnkey basis and laying 11 kV UG cable.

The pole erection work was tendered by the Assistant Engineer, Electrical Section, Kazhakoottam and the remaining three works were tendered by the Executive Engineer, Electrical Division, Kazhakkoottam as per the direction issued by the Deputy Chief Engineer, Electrical Circle, Thiruvananthapuram.

The PAC amount for RMU erection and interconnection of RMU work including RMU is ₹95,85,500/-. Three firms participated in the e-tender and M/s. Linsta Services quoted the lowest rates. But, the quoted amount of M/s. Linsta Services for the erection and interconnection of RMUs along with the rate of RMU comes to ₹1,42,33,927/-, which is 48.49% above PAC.

The Deputy Chief Engineer, Electrical Circle, Thiruvananthapuram reported that, the quoted rates by M/s. Linsta Services is their rock bottom rate, as the cost of materials for the manufacturing of RMU has increased by 30 to 40% recently. It is also reported that the rates included in the estimate was based on the rates for Distribution works on 27.04.2018. As per intimation of the suppliers, the quoted rates are based on the revised supply rate with effect from 01.04.2022.

Hence sanction was requested to approve the lowest quoted rate (which is 48.49% above PAC) for the work "11 kV Power System at M/s. KINFRA International Apparel Parks Ltd., Menamkulam under Electrical Section, Kazhakkoottam.

The matter was placed before Full Time Directors as per note read as 6th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 15.07.2022, resolved to accord sanction to the Executive Engineer, Electrical Division, Kazhakkoottam, to accept the lowest rate quoted by M/s. Linsta Services which is 48.49% above PAC for the work "11 kV Power System at M/s. KINFRA International Apparel Parks Ltd., Menamkulam under Electrical Section, Kazhakkoottam", as requested by the Deputy Chief Engineer, Electrical Circle, Thiruvananthapuram.

Orders are issued accordingly.
