ORDER

Filament Free Kerala (FFK) is one of the flagship projects of Government of Kerala under "Urja Kerala Mission" Scheme. The State wide distribution of the LED bulbs as per FFK was inaugurated by the Honorable Chief Minister of Kerala on 07.01.2021.

In the circular read as 6th paper above, it was directed to distribute the LED Bulbs at the consumer's premises by the staff of KSEBL and to utilise the service of Meter Readers. The Executive Engineers, Electrical Division, Cherthala and Alappuzha as per letters read as 7th and 8th above, have reported that the Meter Readers have requested a minimum remuneration of Rs.10/- per consumer for distributing the LED bulbs at the doorstep of each consumer and requested sanction for the same.

Vide Board Order read as 3rd above, the rate per consumer for taking energy meter reading at different locations being issued to Meter readers engaged on contract basis was fixed as shown below.

As per BO read as 2nd above, the Chief Engineers of Distribution Regions are authorised to sanction only a maximum of 10% of excess running kilometers of the vehicles of Electrical Sections over their permitted monthly running kilometers under their jurisdiction, on the basis of a case to case judicious analysis. If it exceeds 10%, a proposal shall be submitted to the Board with detailed justification.

To ensure successful distribution of LED bulbs and early completion of the project, it was directed to utilise the vehicle of Electrical Sections if required. Considering the circumstances, requests from various offices are likely to be received for ratifying the excess kilometers run for the distribution of LEDs, at Chief Engineers' level.

Hence it is proposed that the Distribution Chief Engineers concerned may be delegated to issue sanction for excess running kilometers of the vehicles of Electrical Sections during the period from January to March 2021, up to a maximum of 1000 kilometers per month, over their permitted running kilometers, in connection with the distribution of LEDs under FFK project, as a special case.

The matter was placed before the Full Time Directors as per Note read as 9th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 28.01.2021,

- Resolved to accord sanction to pay the Meter Readers on contract, remuneration per consumer at rates as per the current rates for meter reading in the particular area as per BO read as 3rd above, for the smooth conduct of LED distribution at the doorstep of the consumer.
- 2. Further resolved to authorize the Chief Engineers of Distribution Regions to ratify the excess running kilometers of the vehicles of Electrical Sections under their jurisdiction, for the distribution of LEDs, during the period from January to March 2021, up to a maximum of 1000 kilometers per month, over their permitted running kilometers, under their jurisdiction, on a judicious analysis of each case.
- 3. Further resolved to authorise the Director (Distribution, IT and HRM) to ratify the excess running kilometers of the vehicles of Electrical Sections for the distribution of LEDs, beyond 1000 kilometers per month for the distribution of LED Bulbs, as a special case.

Orders are issued accordingly.
