ORDER

As per the B.Or read as 1st above, One Time Settlement scheme has been implemented from 21.03.2022 to 20.05.2022. The Chief Engineer, Distribution (Central) Region, as per the letter read as 6th above, reported that due to the short period of OTS, several consumers could not submit their OTS applications within the specified time limit. It is also reported that several applications from the consumers have been receiving in the distribution offices for inclusion in OTS-2022 scheme, even after the expiry of the time limit.

As several requests were received from the consumers as well as from field offices, it was suggested to extend the OTS scheme up to 31.08.2022.

The matter was placed before the Full Time Directors as per the Note read as 9th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 15.07.2022, resolved to authorise the Chief Engineer (Commercial & Tariff) to take up with the Hon. Kerala State Electricity Regulatory Commission to extend the One Time Settlement Scheme 2022 period up to 31.08.2022 as several requests are coming from the consumers as well as from field offices.
