KSERC order on Fuel surcharge @ 25 paise per unit from all categories of consumers for the consumption from 1st April-2010- exempting domestic consumers with monthly consumption upto 120 units from payment of fuel surcharge from 1st April-2010 for a period of six months- Sanctioned- Orders issued

ORDER

KSERC vide the order read as 1st paper above has approved an additional liability of Rs 196.59 crore for the period from April to September-2009 and also ordered to realize the additional liability from all consumers (except domestic consumers with monthly consumption less than or equal to 20 units and connected load less than or equal to 500W) @ 25 paise per unit for the consumption from 1st April-2010. Accordingly Board vide the order read as 2nd paper above has ordered to comply with the order of the Hon'ble Commission and issued necessary directions to all functional units and field offices to collect the fuel surcharge @ 25 paise per unit for the consumption from 1st April-2010. Board has also authorized the Deputy Chief Engineer (TRAC) to issue necessary billing procedures for collecting the fuel surcharge as ordered by the Commission.

2. Government vide the order read as 3rd paper above has ordered to provide Rs 54.core as subsidy for exempting domestic consumers with monthly consumption up to 120 units from payment of fuel surcharge for six months from 1st April-2010 to 30-09-2010.

3. Chief Engineer (Commercial & Tariff) vide the note read as 4th paper above has placed the Government Order before the Board for approval for compliance and further necessary orders for implementation. Having considered the recommendation of the Chief Engineer (Commercial & Tariff), Board here by orders to:

- (1) Exempt domestic consumers with monthly consumption up to 120 units from payment of fuel surcharge @ 25 paise per unit from 1st April-2010 for six months in view of the Government Order G.O (Ms) No. 9/10/PD dated 21-04-2010.
- (2) The Director (IT), all the field offices and ARU's to show the fuel surcharge in the invoices for the domestic consumers with monthly consumption upto 120 units as fuel surcharge and subsidy receivable from the Government separately. The total charges to be recovered

from domestic consumers with monthly consumption upto 120 units shall be excluding the fuel surcharge.

- (3) The Financial Advisor to issue necessary instructions to all the field offices / ARUs to account the fuel surcharge for the domestic consumers with monthly consumption up to 120 units as subsidy receivable from Government separately.
- (4) The Financial Advisor to take necessary steps to get the subsidy from Government on monthly basis, on account of exempting domestic consumers with monthly consumption upto 120 units.
- (5) Communicate the Government Order before the KSERC for information.
- (6) Issue the circular and billing procedures for collecting the fuel surcharge to the field offices.

Orders are issued accordingly.
