<u>ORDER</u>

The Executive Engineer, O/o the Member (Transmission), had sought clarification on the amounts to be collected as Application fee and Processing fee from the prospective EHT consumers vide letter read as 1st paper above. The Board had earlier issued orders revising service and miscellaneous charges including application fee for different categories of consumers vide Board Order read as 2nd paper above. Similarly Board had issued orders to collect power allocation processing fee for different category of consumers vide Board Order read as 3rd paper above.

Later, Supply Code 2005 was issued by the Kerala State Electricity Regulatory Commission, in which Application fee to be collected from different consumers is specified in Chapter III, clause 5 (4). But there is no mention regarding power allocation processing fee. Hence doubts are raised by the field officers regarding collection of application fee and processing fee. The Chief Engineer (Commercial & Tariff) had presented the matter before the Full Time Members vide his note read as (4) paper.

Having considered the above matters in detail, the Board orders that

i) Application fee for different categories of consumers shall be collected as per clause 5(4) of chapter III of Supply Code, which is as follows:

System of Supply	Application fee (Rs.)
LT Supply	25
HT Supply	1000
EHT Supply	5000

ii) The power allocation processing fee shall be collected as per Board Order read as (3) above, which is given below:

Category	Processing fee (Rs.)
Power allocation for 10 kVA to 50 kVA	100.00
Power allocation for 51 kVA to 150 kVA	500.00
Power allocation for 151 kVA to 1000 kVA	5,000.00
Power allocation for 1001kVA to 6000 kVA	10,000.00
Above 6000 kVA (for EHT Power allocation)	15,000.00
