ORDER

As part of the Digital India initiative, the Ministry of Electronics & Information Technology (MeitY) has launched Jeevan Pramaan portal to facilitate Digital Life Certificate for the pensioners, using the Aadhar enabled Biometric authentication mechanism for the generation of DLC. As a suitable solution for the implementation of DLC in KSEBL, the Postal Department has submitted a proposal read as 1St above for integrating their server with KSEBL server for fetching live life certificates, generated by visiting the pensioner's residence, as per their request and after collecting applicable service charge from the pensioner.

The proposal was placed before the Full Time Directors, as per the note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 18.03.2023,

Resolved to adopt the DLC (Digital Life Certificate) of Jeevan Praman Portal of Ministry of Electronics and Information Technology for pension disbursing in KSEBL.

Further resolved to integrate the postal department server with the KSEBL server for fetching of the live life certificates for disbursing pension and also to entrust the postal department for the generation of life certificate by visiting the pensioner's residence as per the pensioner's request.

Further resolved to authorise the Chief Engineer (IT,CR & CAPs) as the authorized representative for registering "KSEBL" as both Pension Sanctioning Agency and Pension Disbursing Agency in this regard and to issue work order to Postal Department for the work mentioned above.
