ORDER

In view of the lock down announced by the State Government, Contractual/ Casual/Daily Wage/Outsourced Staff stand to lose monetarily if they do not come to office.

Government have examined the matter in detail and are pleased to issue orders as follows:

- 1. All the Contractual/Casual/Daily Wage/Outsourced Staff including teachers who are regulated by the Orders in force issued by Government shall be treated as "on duty' on those days in which they are not able to come to office due to restrictions attributed to COVID 19.
- 2. This shall apply from 24th March 2020 to 30th April 2020. In the case of teachers, the date shall be from 19th March 2020 to 31st March 2020.
- 3. In the case of teachers who has the benefit of vacation, but are not having official duty are not eligible for benefits of this order, whereas those teachers who have to attend official duty during vacation may avail the benefit of this order.
- 4. The GO read above would be made applicable where ever necessary.
