### ORDER

The eligibility for TA/DA of employees of KSEB Ltd is being governed by the Order read as per 1<sup>st</sup> above. As per the Board Order, the workmen under Grade II (a) & II (b) are eligible for 1<sup>st</sup> class train journey. The Deputy Chief Engineer (HRM – II), as per note read as 2<sup>nd</sup>, has reported that due to the absence of 1<sup>st</sup> class compartments in most of the trains, the employees under Grade II (a) & II (b), who are eligible for 1<sup>st</sup> class train journey, are claiming 3<sup>rd</sup> AC train fare, which is cheaper than 1<sup>st</sup> class fare beyond 215 km. The Deputy Chief Engineer (HRM – II) also sought clarification regarding the admissibility of 3<sup>rd</sup> AC train fare in respect of Grade II (a) & II (b) employees.

The matter was placed before the Board Meeting as per note read 3<sup>rd</sup> above. Having considered the matter in detail, the Board of Directors in its 52<sup>nd</sup> meeting held on 04.03.2020 resolved to permit the employees belonging to Grade II (a) & II (b), who are eligible for 1<sup>st</sup> class train journey, to claim 3<sup>rd</sup> AC train fare in the absence of 1<sup>st</sup> class compartments in trains.


