ORDER

The NHAI has proposed 6 laning of the NH-66 (old NH 47) road from Cherthala – Oachira – Kazhakkootom, and as part of the 6 laning works all the existing KSEBL utilities are required to be shifted. The shifting work is to be carried out by NHAI with their own fund under the supervision of KSEBL.

The Chief Engineer, Distribution South forwarded as per letter read as 3rd above, estimates totaling to ₹ 53,44,66,205/- for shifting of utilities in package III & IV of fourteen Electrical Sections under Electrical Circle, Kollam, as detailed below, for the consent from the full Time Directors, as the estimate amount is beyond the limits of the Chief Engineer.

As per the BO read as 2nd above, sanction was accorded to restrict the supervision charges to 2.5% of the total approved cost in case of utility shifting for National Highway Authority of India (NHAI) projects.

As per the above estimate, the amount to be remitted to KSEBL by the NHAI is ₹1,30,35,761/- out of which ₹1,10,47,255/- is the supervision charge and ₹19,88,506 is its GST.

As per Clause 8(1) of Annexure (1) to the B.O. read as 1st above, the Chief Engineer is delegated with the power for granting Administrative and Technical Sanction upto Rs.5 Crore, for deposit works to be carried out by KSEBL after collecting the cost from the applicant or works being carried out by the beneficiary themselves under the supervision of KSEBL's officials after collecting supervision charge; for works above 5 Crore, the consent of the full time Directors is to be obtained.

The matter was placed before the Full Time Directors as per note read as 4th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 23/04/2021,

1. Resolved to accord sanction to the Chief Engineer, Distribution South for granting Administrative Sanction after detailed scrutiny of the estimate, for the deposit work for shifting of utilities for road widening work in Package III & IV of fourteen Electrical Sections under Electrical Circle, Kollam as detailed in tables above.
2. Further resolved to direct the Chief Engineer (Distribution South) to adjust the amount remitted by NHAI for the utility shifting based on actuals after the completion of work, under respective Electrical Divisions, after taking into account the value of taken back materials.

Orders are issued accordingly.
