ORDER

The Deputy Chief Engineer, Electrical Circle, Kottarakkara, as per letter read as 7th above, sought sanction for processing the request from M/s Star industries, Ayoor, an HT consumer (LCN 12/6765) under Electrical Section, Ayoor, with disputed arrears, for enhancing their contract demand from 450 kVA to 500 kVA. It was reported that the consumer was given a final assessment bill of ₹ 41,04,697/- for unauthorised additional load following an APTS inspection on 28.12.2019. The consumer approached the Appellate authority after remitting the mandatory 50% amount and the case is pending disposal. The consumer has also a current charge arrears of ₹ 26,65,670/- pending realisation for which he has been granted installments (and of which the first installment has been remitted).

As per Reg 99(4) of the Supply code 2014,' the application for enhancement of load shall not be considered if the consumer is in arrears of payment of the dues payable to the licensee'

The request from the Deputy Chief Engineer, Electrical Circle, Kottarakkara for processing the application for load enhancement from M/s Star industries, Ayoor, an HT consumer (LCN

12/6765) under Electrical Section, Ayoor, with disputed arrears, for enhancing their contract demand from 450 kVA to 500 kVA was placed before the Full Time Directors for a decision.

Having considered the matter in detail, the Full Time Directors in the meeting held on 16/04/2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Kottarakkara, for processing the application for load enhancement from the HT consumer, M/s Star industries, Ayoor, (LCN 12/6765) under Electrical Section, Ayoor, with pending arrears under dispute (pending disposal before the Appellate Authority).

Further resolved to direct the Deputy Chief Engineer to ensure that an undertaking in stamp paper is obtained from the consumer agreeing to remit the arrears as and when the cases are finally settled.

Orders are issued accordingly.
