## **ABSTRACT**

Standardisation of 60 Nos DTR Locations - PMU work under Electrical Section, Vellanad – single valid bid on re-tendering- ratification – sanctioned -- Orders issued.

## **ORDER**

The Chief Engineer, Distribution South as per letter read as 3<sup>rd</sup> above, has sought ratification of a sanction given inadvertently by the Circle level Committee for awarding the PMU work of standardisation of 60 DTR locations under Electrical Circle, Kattakkada, to the single bidder (on retendering), whereas as per the Board directions, the matter was to be taken up with the Full time directors for sanction since the PAC exceeded Rs 5 lakhs.

An E tender was invited by the Executive Engineer, PMU, Kattakkada for the Dyuthi work of standardization of 60 numbers of DTR locations under Electrical Section, Vellanad with PAC of ₹16,56,009/-. Since no bidders turned up, the date was extended to 30.11.2020 and since still no bidder participated, the E tender was canceled. The work was re tendered on 21.12.2020. Since no bidders participated, the date was extended to 7.1.2021. Only a single bidder Sri Shaji R, Benoy Associates, Thiruvallom P.O participated and the quoted rate was 1% below the estimate rate.

Even though, as per the BO read as 2<sup>nd</sup> above, the matter was to be placed before the Full Time Directors for decision, by mistake, this work was included for sanction at the Circle level Committee held at 3 pm on 12.01.2021 through Google meet, and the Circle Level Committee issued sanction for awarding work order to Sri Shaji, Benoy Associates, Thiruvallom P.O at his quoted rate of 1% below estimate rate.

As per Clause 4(d) (iv) of the G.O. read as 1<sup>st</sup> above, a single bid during re-tender shall be accepted only with the approval of Committee of Secretaries/Government Tender Committee or a Committee headed by the Head of the Department/Institution, with Finance Officer (or equivalent) and the Tender Inviting Authority as members, as per delegation of tender acceptance in force.

As per the Board order read as 2<sup>nd</sup> above, the Circle level committee is delegated to sanction the single quotation/tender received for offers to carry out the Dyuthi project petty contract works at estimate amount / below estimate amount after retendering, and the Chief Engineer level committee is delegated to sanction the single quotation / tender received for offers to carry out such works with overall tender excess of up to 5% above PAC after retendering, for all works with PAC up to ₹ 5 Lakhs only.

Since PAC in case of the work exceeds ₹ 5 Lakhs, the Chief Engineer requested ratification of the above sanction, as per letter read as 3<sup>rd</sup> above, and the matter was placed before the Full Time Directors for a decision, as per note read as 4<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 07/05/21, resolved to ratify the action of the Circle Level committee of issuing sanction for awarding the Dyuthi work of standardization of 60 numbers of DTR locations under Electrical Section, Vellanad with PAC of ₹ 16,56,009/- for which only single tender was received on retendering, to the single bidder, Sri Shaji R, Benoy Associates, Thiruvallom P.O, at 1% below the estimate rate.

Orders are issued accordingly.
