## **ORDER**

The Deputy Chief Engineer, Electrical Circle , Shoranur as per letter read as 1<sup>st</sup> above has forwarded the request of Sri.Rangan, S/o Nanchan and family under Electrical Section Agali, for getting free electric connection to his traditional farming along with the decision noted in the Sandvanasparsam Adalath held on 11.02.2021 at Agali and the estimate to the extent of Rs 1,36,694/-for effecting three phase agriculture service connection by constructing LT three phase 4 wire line (up to and including 100m) and conversion of single phase line to three phase (450 m).

The applicant belongs to Scheduled Tribe and BPL Category. According to the Adalath decision the Deputy Chief Engineer, Electrical Circle, Shoranur was directed to take action to effect the service connection for agriculture purpose as in the case of domestic consumers having over head length above 200M free of cost, considering that they belong to scheduled tribe. As per the existing rules there is no provision for effecting free agriculture service connection to any category of consumers, hence the Deputy Chief Engineer, Electrical Circle, Shoranur forwarded the request for a decision.

The matter was placed before the Full Time Directors as per note read as 3<sup>d</sup> above for a decision.

Having considered the matter in detail, the Full Time Directors in the meeting held on 17.05.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Shoranur to effect three phase agriculture service connection in favour of Sri. Rangan who belongs to Scheduled Tribe and comes under BPL category, by constructing LT three phase 4 wire line (up to and including 100m) and conversion of Single Phase Line to Three Phase (450 m) using Board's fund as a special case.

Orders are issued accordingly.
