#### **ORDER**

Sri. Babu. M.K, Superintendent, Electrical Section, Parappukkara joined Kerala State Electricity Board service on 13.03.2021 FN as Cashier. He had prior service in Revenue Department from 05.06.1999 FN to 09.03.2001 AN. The above service was reckoned and recorded in the Service Book of the incumbent. Sri. Babu. M.K was relieved from Revenue Department on 09.03.2001 AN and joined KSEB on 13.03.2001 AN as 10.03.2001 and 11.03.2001 were Second Saturday and Sunday respectively. He was supposed to join on 12.03.2001 FN. But he could join KSEB Service only on 13.03.2001 FN as a Hartal was announced by political parties on 12.03.2001. The whole batch of Cashiers/Junior Assistants were allowed to join duty on 13.03.2001 and hence he also joined duty on the above said date.

As such there occurred a break in service of one day on 12.03.2001 which is not allowable as per the existing rules. Hence the Chief Engineer (HRM) has requested to condone the break in service of one day on 12.03.2001 in respect of Sri. Babu. M.K.

In a similar case, KSEBL has accorded sanction to condone the break in service of Sri. Joy. A.J, Senior Assistant, RCA Pre-Check Unit, Thrissur as per Board Order read as  $4^{th}$  above. The decision was taken in line with Board Orders read as  $2^{nd}$  and  $3^{rd}$  above.

The matter was placed before the Full Time Directors as per note read as  $5^{\text{th}}$  above.

Having considered the matter the Full Time Directors in the meeting held on 07.05.2022 resolved to condone the break in service on 12.03.2001 in respect of Sri. Babu. M.K, Superintendent, Electrical Section, Parappukkara in line with Board Orders  $2^{nd}$ ,  $3^{rd}$  and  $4^{th}$  above.
