## ORDER

The Department of Power has proposed to implement Self Meter reading to consumers with an option to choose self reading. The Chief Engineer (IT, CR & CAPSs) in the note read as 2<sup>nd</sup> above has reported that, KSEBL has already taken initiatives and successfully implemented self meter reading during Covid 19 pandemic to address the issue of average bills to consumers in the containment zone where meter readers were not able to visit the premise.

In view of the above, the Chief Engineer (IT, CR & CAPSs) has recommended to extend this facility of self meter reading to the registered consumers in two Electrical Sections each (one rural and one urban) from the four Distribution Regions, on a pilot basis and to further roll out to all Electrical Sections on successful completion of the pilot.

Having considered the matter in detail the Full Time Directors in its meeting held on 21.04.2022, has resolved to accord sanction to implement self meter reading to registered consumers on a pilot basis in two Electrical Sections each (one rural and one urban) from the four Distribution Regions and to further roll out to all Electrical Sections on successful completion of the pilot implementation without any financial loss to KSEBL under consistent monitoring by Director(Distribution & IT)
