Purchase of 250km of LT XLPE insulated ACSR Conductors from M/s.Traco Cable Co Ltd and uses it for pilot implementation in selected areas under 25 Electrical Circles-Orders Issued.

ORDER

In the meeting convened on 14/07/2021 by the Honorable Minister for Finance in the presence of Honorable Minister for Law & Industries and Honorable Minister for Electricity, it was suggested that KSEBL can consider issuing the supply order for XLPE insulated ACSR conductor to M/s.Traco Cable Company Limited after getting type test certificates from Central Power Research Institute (CPRI) and M/s.Traco Cable Company Limited vide letter dated 01/09/2021 had submitted the type test report of XLPE insulated ACSR Rabbit/Raccoon conductors from CPRI, Bangalore.

Subsequent to the above, the Distribution Core committee meeting held on 07/01/2022 suggested that a small quantity of LT insulated cable could be considered for purchase and put to further pilot implementation in selected areas of all Electrical Circles-10km in each circle and also decided to recommend the purchase of 250km of LT insulated

cable from M/s.Traco Cable Co.Ltd and use it for pilot implementation in selected areas of 25 Electrical Circles.

The matter was placed before the Full Time Directors meeting held on 30/04/2022 and it was directed to resubmit the same with approximate financial commitment.

Accordingly based on the offer read as (4th) above submitted by M/s Traco Cable Co.Ltd, the approximate financial commitment incurred to the Board was calculated as Rs.2,22,23,807/- (Rupees Two crore Twenty Two lakh Twenty Three Thousand Eight hundred and Seven only) (Excluding freight charges and including GST@18%) and resubmitted the same before the Full Time Directors meeting held on 07/05/2022.

The Full Time Directors' meeting after having a detailed discussion decided to place matter before the next Director Board meeting for a decision. Accordingly, the matter was placed before the Board of Directors meeting held on 12.05.2022 as per the note read as (6th) above.

Having considered the matter in detail, the Board of Directors resolved to authorize the Chief Engineer (SCM) to purchase 250 km of LT XLPE insulated ACSR Rabbit Conductor from M/s.Traco Cable Company Limited and to use it for pilot implementation in select areas under all the 25 Electrical Circles. The approximate financial commitment to the KSEBL to purchase of 250 km of LT insulated cable from M/s.Traco Cables Co. Ltd is Rs.2,22,23,807/-

(Rupees Two Crore Twenty Two lakh Twenty Three Thousand Eight Hundred and Seven Only) excluding freight charges and including GST@18%. The price quoted in the offer for ACSR conductor is variable based on IEEMA price variation formula.

It was also resolved to authorize the Full time directors to internally review the rate quoted by M/s.Traco for LT XLPE insulated ACSR conductors.

Orders are issued accordingly.
