ORDER

The Deputy Chief Engineer, Electrical Circle, Irinjalakuda as per the letter read as 1st above, has informed that an existing LT consumer (consumer number: 1156592013749) of Kerala Water Authority at Elanthikara under Electrical Section Puthenvelikkara has submitted application for enhancement to HT connection after installing a 200kVA transformer at water treatment plant. The existing dedicated HT ABC feeder has to be extended to a length of 10 meter towards newly erected 4 pole structure with CT /PT unit for providing HT connection to the consumer.

Even though Kerala Water Authority has remitted the work deposit amount of ₹.73000/- under new HT service connection, the work was not been carried out as the consumer is having an outstanding arrears including surcharge amounting to ₹.90,14,962/- as on 4/2022 against the existing LT 4A connection.

The Deputy Chief Engineer, Electrical Circle, Irinjalakuda as per the letter read as 2nd above, has reported that Administrative Sanction for the work was issued by the then Deputy Chief Engineer, Electrical Circle, Irinjalakuda on 13.10.2021 based on the undertaking submitted by the Executive Engineer, Kerala Water Authority, PH Division, Aluva to the effect that the arrears will be paid at the earliest.

The existing LT connection of M/s KWA has connected load of 50kW and contract demand of 56kVA under LT 4A tariff.

The Chief Engineer, Distribution Central as per the letter read as 3rd above has also reported that there is a lot of pressure from the local body to effect the connection.

Hence, the matter was placed before the Full Time Directors as per the note read as 4th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 17.05.2022,

- Resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Irinjalakuda to carry out the work of enhancement of existing LT connection of KWA at Elanthikara under Electrical Section Puthenvelikkara to HT connection, based on the undertaking submitted by the Executive Engineer, Kerala Water Authority, PH Division, Aluva to the effect that the arrears will be paid at the earliest.
- Further resolved to direct the Deputy Chief Engineer, Electrical Circle Irinjalakuda to forward
 the arrear details of the consumer to the Special Officer (Revenue) to include in the HT bills
 issued to the consumer.
