Enhancement of connected load and contract demand of existing LT connection of Kerala Water Authority at Irinjalakuda under Electrical Section, Irinjalakuda No.I - Sanctioned - Orders Issued.

ORDER

The Deputy Chief Engineer, Electrical Circle, Irinjalakuda as per the letter read as 1st above, has informed that an existing LT consumer with consumer number 1156448011014 of Kerala Water Authority under Electrical Section, Irinjalakuda No. I has submitted application for enhancing connected load and contract demand. The present connected load is 56kW and contract demand is 56kVA which are to be enhanced to 100kVA and 80kVA respectively. It was further reported that additional load and contract demand can be given from existing distribution network without carrying any work.

The consumer is having an outstanding arrear of ₹38,52,974/- as on 4/2022 against the existing LT 4-A connection. It was also remarked that there is a lot of pressure from the local body to enhance the load.

The Deputy Chief Engineer, Electrical Circle, Irinjalakuda, has sought necessary direction/ clarification, in this regard, whether to proceed with the enhancement of the load of the consumer, who is has pending arrears.

The matter was placed before the Full Time Directors as per the note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 30.05.2022, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Irinjalakuda, to enhance the connected load and contract demand of existing LT connection with consumer number 1156448011014 of Kerala Water Authority at Irinjalakuda under Electrical Section Irinjalakuda No.I, as a special case, after obtaining an undertaking to remit the balance amount at the earliest, considering it as a Government institution.
