ORDER

The Deputy Chief Engineer, Electrical Circle, Haripad as per the letter read as 4th above, has reported that an existing HT service connection for the KWA Pump house at Mavelikkara in favor of M/s. Kerala Water Authority, TEAP Division, Kayamkulam, having a connected load of 333kW and contract demand of 250KVA has submitted application and connected documents for enhancing connected load and contract demand to 450kW and 260KVA respectively, before the Executive Engineer, Electrical Division, Mavelikkara.

The Special Officer (Revenue) as per the letter read as 2nd above, has reported that the M/s. Kerala Water Authority, KWA, TEAP Division, Kayamkulam (HTB No.17/5114) is having an arrear of ₹2,63,48,053/- (Rupees Two Crore Sixty Three lakhs Forty Eight Thousand and Fifty Three) as on 09.05.2022, pending for realization without interest. The Deputy Chief Engineer, Electrical Circle, Haripad, as per the letter read as 3rd above, has sent a letter to M/s.KWA authority to remit the arrears.

The Executive Engineer, KWA, PH Division, Kollam, as per letter read as 1st above, has intimated that the enhancement of connected load and contract demand of the existing HT service connection is for Jal Jeevan Mission which is to ensure water supply in Karunagappally Municipality and adjoining Panchayaths such as Oachira, Clappana and Alappad to alleviate water scarcity. As a part of this, "Supply, erection and installation of 300HP VT Motor and 630kV outdoor transformer at Kandiyoorkadavu Raw Water pump house" has been completed. It was further intimated that obtaining fund for arrear charges and its subsequent remittance might take time and hence would delay the commissioning of the project which was already being approved by the Electrical Inspectorate and requested to execute the agreement without insisting on immediate payment of back arrears and assured that the same will be paid immediately on receipt of funds from KWA head office.


Hence, the Deputy Chief Engineer, Electrical Circle, Haripad has sought necessary direction on execution of supplementary agreement before remittance of arrears as a special case.

The matter was placed before the Full Time Directors as per note read as 5th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 30.05.2022, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Haripad, to execute supplementary agreement for enhancement connected load and contract demand of the HT service connection for KWA Pump House, Mavelikkara in favor of M/s.KWA, TEAP Division, Kayamkulam (HTB No.17/5114), for commissioning of project under Jal Jeevan Mission, after obtaining an undertaking from KWA that the arrear amount will be remitted at the earliest, as a special case.


