### ABSTRACT

Conversion of supply from HT to EHT connection with a contract demand of 11000kVA for M/s.MES - Request for adjusting the existing security Deposit of HT connection to EHT - Sanction Accorded - Orders issued.

### ORDER

The Chief Engineer Distribution (Central), Ernakulam, as per letter read as 1<sup>st</sup> above, informed that Garrison Engineer (NS) Kattaribagh, Naval Base, Kochi, an HT consumer with consumer nos. LCN: 16/1616 & LCN: 2/207 has applied for enhancement of contract demand from 9700kVA to 11000kVA and conversion of service from HT to EHT. The Deputy Chief Engineer, Transmission Circle, Kalamassery, has reported that the work of conversion of HT to EHT at 110kV level with a contract demand of 11000kVA is feasible with some development works at 110kV substation Willington Island and the estimate for the same which amounts to ₹1.31 crore have been remitted by M/s. MES.

The Special Officer (Revenue) informed that there are no arrears pending for realization against the consumer nos. LCN-16/1616 and LCN-2/207 in favour of the Garrison Engineer.

The Chief Engineer Distribution(Central) intimated the Garrison Engineer to remit a security deposit of ₹5,08,57,950/- (Rupees Five Crore Eight Lakhs Fifty Seven Thousand Nine Hundred and Fifty Only) and to execute the Codicil Agreement after executing the connectivity Agreement with the Chief Engineer Transmission (South).

In reply the Garrison Engineer has requested to adjust the existing security deposit amount available for the HT connections LCN 16/1616 & LCN 2/2017 towards the security deposit of the new 110kV EHT connection.

The details of security deposit available are as follows:

The Garrison Engineer has expressed willingness to remit the balance amount of ₹60,35,030/-. The HT connection will only be surrendered on energization of 110kV EHT connection. Since, M/s. MES is Defence Services and they are not having any pending arrears, the Chief Engineer Distribution (Central) has recommended to consider the request favourably.

The Chief Engineer (Commercial and Tariff), as per note read as 2<sup>nd</sup> above, has opined that both the consumer nos. LCN:16/1616 & LCN: 2/207 are in the name of Garrison Engineer (NS) and the consumer does not have any arrear pending. After conversion from HT to EHT the consumer numbers may vary but again it will be in the name of Garrison Engineer (NS).

Further the provisions in Regulation 69(2) of Kerala Electricity Supply Code 2014 permits only additional security to cover the additional consumption in the case of enhancement of load. Considering all the above, the request received from the Garrison Engineer (NS) to adjust the existing security deposit for the conversion of supply from HT to EHT connection with a contract demand of 11000kVA can be considered favourably. It is also opined that M/s. Garrison Engineer (NS) has to execute all the procedural formalities for the conversion of supply from HT to EHT connection. The details of the codicil agreement and consumer nos may be forwarded to the office of Chief Engineer (Commercial and Tariff) after completing the formalities so as to modify the annexures of model agreement executed between M/s. KSEBL and M/s. MES.

The matter was placed before the Full Time Directors as per the note read as 3<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 30.05.2022 resolved to consider the request received from the Garrison Engineer (NS) to adjust the existing security deposit available against the HT connections LCN:16/1616 & LCN: 2/207 in favour of the Garrison Engineer, towards the security deposit of the new 110kV EHT connection request.

Further resolved to permit the Chief Engineer Distribution (Central) for adjusting the Security Deposit amount available for the HT connections LCN: 16/1616 & LCN:2/207 towards the Security Deposit of the new 110kV EHT connection in favour of M/s. Garrison Engineer and to

collect the balance amount towards the security deposit, through the Special Officer (Revenue), after ensuring that the Garrison Engineer (NS) execute all the procedural formalities for the conversion of supply from HT to EHT connection and to forward the details of codicil agreement and consumer numbers to the Chief Engineer (Commercial and Tariff) after completing all formalities so as to modify the annexure of model agreement executed between M/s. KSEBL and M/s. MES.

Further resolved to authorize the Chief Engineer (IT & CR) to make necessary adjustments in the Engerise software for the above.

Orders are issued accordingly.
