NHAI- Shifting of utilities for road widening work along NH-66 from Nileschwaram to Muzhapilangad portion under Electrical Circles, Kasargode, Sreekandapuram and Kannur – Consent for carrying out works above Rs 5 Crore on work deposit basis – Sanctioned – Orders issued.

ORDER

The widening of Thalappady to Vengalam National Highway (189 km) from 2 lanes to 6 lanes of NH-66 is under the bidding by National Highway Authority of India (NHAI). The Project Director, NHAI, Project Implementation Unit (PIU), Kozhikode, has requested to furnish the estimate for shifting the electrical installations along the side of National Highway in connection with road widening work. As per D.O. letter read as 3rd above, it was intimated that the shifting shall be done by NHAI with their fund under the supervision of KSEBL as detailed below.

The entire works of shifting the electrical installations as requested by NHA from Thalappady to Vengalam along the side of NH-66 comes are located under the jurisdiction of Electrical Circles Kasaragod, Sreekandapuram, Kannur and VadaKara. Hence, it is proposed to furnish Circle wise estimates for each stretch of the project.

KSEBL as per BO read as 6th above, has accorded Administrative Sanction for the revised estimate of Rs.50,41,27,789/- (Rupees Fifty Crore Forty One Lakh Twenty Seven Thousand Seven Hundred and Eighty Nine only) for the work for shifting of utilities for road widening work from portions of Thalappady – Chengala and Chengala- Nileshwaram reach of NH-66 (i.e. part 1 and 2 of the request of NHA) under the jurisdiction of Electrical Circle Kasargode, on work deposit basis after scrutiny of the estimate with the condition that the amount remitted by NHA for the utility shifting shall be adjusted based on actuals after the completion of the work under respective Electrical Divisions after taking into account the value of taken back materials.

The Chief Engineer (Distribution- North Malabar), has furnished the revised estimate for shifting of electrical utilities in Nileshwaram - Thaliparamba reach under Electrical Circle Kasargode as per letter read as 7th above, Nileshwaram - Thaliparamba reach under Electrical Circle Sreekandapuram and Thaliparamba- Muzhapilangad under Electrical Circle Sreekandapuram as per letter read as 8th above and Thaliparamba- Muzhapilangad under Electrical Circle Kannur as per letter read as 5th above and requested consent for issuing sanction for carrying out the subject work.

Of the estimate submitted, the Nileshwaram - Thaliparamba reach of the project consists of shifting of utilities under Electrical Circle Kasargode & Sreekandapuram, Thaliparamba- Muzhapilangad reach of the project consists of shifting of utilities under Electrical Circle Sreekandapuram & Kannur. The amount of estimate for utility shifting along the side of National Highway in connection with road widening work for the portion Nileshwaram – Thaliparamba – Muzhapilangad reach and the Sections covered are as detailed below.

The estimate has been prepared with proposal to lay UG cables in all 33 kV, 11kV and LT Road crossing locations, A-poles for maintaining statutory clearance and construction of lines as per standards. The existing materials that can be reused are not included and only new and additional materials are shown in the material list. There is no up-gradation of the infrastructure and the estimate is for shifting existing utilities only. Also, approved supervision charges of 2.5% of the total approved cost in case of utility shifting for National Highway Authority of India (NHAI) Bharathmala Pariyojana projects have been included in the estimates.

As per Clause 8(1) of Annexure (1) to B.O. read as 1st above, the Chief Engineer is delegated with power for granting Administrative and Technical Sanction upto Rs.5 Crore, for deposit works to be carried out by KSEBL after collecting cost from the applicant or works being carried out by beneficiary themselves under the supervision of KSEBL's officials after collecting supervision charges. For works above 5 Crore, the consent of Full Time Directors is to be obtained. As per BO read as 2nd above, sanction was accorded to restrict the supervision charges to 2.5% of the total approved cost in case of utility shifting for National Highway Authority of India (NHAI) projects.

The Chief Engineer, (Distribution-North Malabar) as per letters read as 5th, 7th and 8th above, has sought the consent of the FTD for carrying out the works under Work Deposit basis for utility shifting for the portion of Nileshwaram – Thaliparamba – Muzhapilangad reach (i.e. part 3 and 4 of the request of NHAI) under Electrical Circles of Kasargode, Sreekandapuram & Kannur.

The matter was placed before the Full Time Directors as per note read as 9th above for a decision.

Having considered the matter in detail, the Full Time Directors in its meeting held on 17/09/2020, resolved to accord sanction to Chief Engineer (Distribution-North Malabar) for granting Administrative Sanction for the Deposit work for shifting of utilities for road widening work for the Nileshwaram – Thaliparamba – Muzhapilangad portion of NH-66, under Electrical Circles, Kasargode, Sreekandapuram & Kannur, as detailed below, after detailed scrutiny of the estimate.


