ORDER

The Government had accorded sanction for Rs 100 lakh under "Innovation and ESCOT Fund" for the year 2018-19, for "Implementing High Voltage Distribution System(HVDS) in Tirur town (Electrical Section, Tirur East)" amounting to Rs 40 lakh and "Standardisation of transformer stations (20 each) under Electrical Circles Kannur, Alappuzha and Tirur" amounting to Rs 60 Lakh, in the Distribution wing.

As the fund for the above projects were not released from the Government, KSEBL as per BO read as 1st above, had accorded sanction to the Secretary (Administration), KSEBL, to meet the expenditure of these projects from KSEBL's own fund for the time being and later recoup the amount from the Government. The above works were completed and utilisation certificate amounting to Rs 94.68 lakh has already been sent to Government as per letter read as 2nd above. But the fund for these projects under Innovation & ESCOT fund for the year 2018-19 have not yet been released by the Government.

Meanwhile, Administrative Sanction was accorded by the Government of Kerala as per GO read as 3rd above, for Rs 670 lakh for implementing various projects under "Innovation & ESCOT fund" for the year 2019-20, of which Rs 100 lakh were sanctioned for works under the Distribution wing, with the condition that the fund be utilised in the current financial year itself. The works under the Distribution wing includes "Construction of 1km 11kV OH line, 1km HT ABC and installation of 20 nos of 15kVA transformers at various locations under Electrical Circle Haripad (High Voltage Distribution System)" for an amount of Rs 46 Lakhs and "Standardisation of 54 transformer stations (14 under Electrical Circle Haripad and 40 under Electrical Circle Sreekandapuram) for an amount of Rs 54 lakh.

Since the funds from the Government have not been received, it was directed that the works on ESCOT projects for the year 2019-20 shall be proceeded only after release of fund from the Government, which was communicated to the respective offices.

The Chief Engineer, Distribution Central, as per letter read as 6th above, has reported that 20 numbers of 16kVA transformers were allocated for the work of "Implementing High Voltage Distribution System" under Electrical Circle Haripad and these are idling.

The HVDS works are not included in "Dyuthi" project or other Plan works and hence the 16 kVA transformers procured cannot be utilised for any other work, unlike the work of "Standardisation of transformer stations" which are already included in Dyuthi works which can be implemented and also does not incur major material purchase.

The Chief Engineer, Distribution Central has suggested that the work of "Implementing High Voltage Distribution System" which includes construction of 1km 11kV OH line, 1km HT ABC and installation of 20 numbers of 15kVA transformers at various locations, under Electrical Circle Haripad sanctioned under Innovation & ESCOT fund for the year 2019-20 may be carried out using KSEBL's fund for the time being, so as to effectively utilize the transformers that have already been procured. The matter was placed before the Full Time Directors for a decision as per Note read as 7th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 25.09.2020, resolved to accord sanction to carry out the work of "Implementing High Voltage Distribution System" which includes construction of 1km 11kV OH line, 1km HT ABC and installation of 20 numbers of 15kVA transformers at various locations, under Electrical Circle Haripad sanctioned under Innovation & ESCOT fund for the year 2019-20 using KSEBL's fund in the same manner as done in 2018-19, so as to effectively utilize the transformers that have already been procured.

Orders are issued accordingly.
