### ORDER

The Bureau of Energy Efficiency has notified the Bureau of Energy Efficiency (Manner and Intervals for Conduct of Energy Audit in Electricity Distribution Companies) Regulations, 2021, to be effective from the 7<sup>th</sup> of October 2021.

The Centralised Energy Accounting and Audit Cell (CEAC) in terms of clause 5 (g) of the Regulations was constituted as per Office order read as 3<sup>rd</sup> above, consisting of the following officials.

1. Nodal Officer – Sri Suresh Kumar C, Chief Engineer (IT, CR & CAPS)
2. Energy Manager – Sri Bijuraj R, Executive Engineer
3. IT Manager – Smt. Mini M Kurian, Executive Engineer
4. Finance Manager – Ajithkumar G, Divisional Accounts Officer.

In view of the directions from the Energy Management Centre-Kerala, the State designated agency for Energy Efficiency, to designate one of the senior Engineers of KSEB Ltd having BEE Energy auditor/ Manager Certification as full time Energy manager of the organisation, Sri Bijuraj R, Executive Engineer, has been appointed as the full time Energy Manager of KSEBL, as per B.O read as 4<sup>th</sup> above.

Consequent to appointment of new Director and subsequent transfer and promotions effected as per B.Os read as 5<sup>th</sup> and 6<sup>th</sup> above, Sri.Hareesan Mottammal has been posted as the Chief Engineer (IT, CR & CAPs), and Smt.Mini M Kurian-IT Manager has been promoted as the Deputy Chief Engineer(IT & CR), and hence the Nodal officer and IT Manager of the Centralised Energy Accounting and Audit Cell (CEAC) are to be replaced. As the data for Energy Audit is to be furnished from the IT Computerisation wing, it is suggested that the Executive Engineer of that wing shall be nominated as the IT Manager.

Under the above circumstances,it was suggested that the Nodal Officer and IT Manager of the Centralised Energy Accounting and Audit Cell (CEAC) be replaced with the following members:

1. Nodal Officer – Sri Hareesan Mottammal, Chief Engineer(IT, CR & CAPs)
2. IT Manager – Smt. Sabida Salam, Executive Engineer-IT Computerisation Unit.

The matter was placed before the Full Time Directors, as per note read as 7<sup>th</sup> above.

Having considered the recommendation of the Chief Engineer (IT, CR & CAPs), the Full Time Directors in the meeting held on 15.07.2022 resolved to accord sanction to re-constitute the Centralised Energy Accounting and Audit Cell (CEAC), constituted in terms of clause 5 (g) of the Regulations with the following officials.

1. Nodal Officer – Sri Hareesan Mottammal, Chief Engineer (IT, CR & CAPs)
2. Energy Manger – Sri Bijuraj R, Executive Engineer/Energy Manager
3. IT Manager – Smt. Sabida Salam, Executive Engineer-IT Computerisation Unit.
4. Finance Manager – Ajithkumar G, Divisional Accounts Officer.


