ORDER

As per the B.O. read as 1st above, KSEBL had accorded sanction for revising the rates for hiring of vehicles to Rs.18 per km for motor cabs having cubic capacity below 1500 cc and Rs.20 per km for motor cabs having cubic capacity 1500 cc and above, by adopting the Government Order read as 3rd above.

In view of the clarifications sought from some of the offices on the B.O read as 1st, the matter was placed before the Full Time Directors as per note read as 5th. Having considered the matter in detail, the Full Time Directors in the meeting held on 22.07.2022, resolved to accord sanction for modifying para numbered as (1) and (2) in the B.O. read as 1st above as follows:

1. If the vehicles are detained beyond 12 hours a day, detention charges @ Rs.50/- per hour, subject to a maximum of Rs.500/- per day can be paid in addition to the kilometer charges. This clause is generally applicable for Electrical Section offices only, where 24 hours vehicle facility is required, whereas for other offices under Distribution, Transmission and Generation wings, this clause shall be applicable only for emergency purposes, which shall be duly certified by the Deputy Chief Engineer concerned.

2. Hiring of vehicles shall be operationalized for a period of one year by the concerned Chief Engineers / Deputy Chief Engineers / Executive Engineers / Project Managers as per their delegation of powers, after inviting competitive open tenders with wide publicity as per norms.

There are no changes in the B.O. read as 1st except the above.
Orders are issued accordingly.
