## **ORDER**

The Deputy Safety Commissioner, Distribution (Central) as per letter read as 1<sup>st</sup> above, reported that an accident occurred under Electrical Section, Maradu on 04.07.2022, where in a school bus with kids accidentally pulled a cable that was sagging across the road leading to the breakage of an electric post it was tied to and the post fell on the bus. The kids were rescued without any causality. A major electrical accident was averted because the 11 kV feeder was under permit.

Other cases of accidents also reported arising due to unauthorised drawal of cables by Cable TV operators & others, without adhering to safety standards and guide lines.

The cable TV operators and others who have drawn cables along KSEBL poles were already directed to tag their cable and to ensure adequate standards as per B.O read as 3<sup>rd</sup> above.

In addition to the accidents to public and public transportation, the cable mesh (more than 10 to 12 cables in a pole) in the poles cause much difficulty to the field staff to carry out routine maintenance and breakdown works on the poles. It badly affects the safety of field workers.

Another related issue raised from the field officers is regarding errection of poles for communication cable along the RoW of HT/LT lines of KSEBL by M/s.Reliance Jio Infocomm Ltd at various locations without maintaining statutory clearance as per Central Electricity Authority (Measures relating to Safety and Electricity Supply) Regulations, 2010, causing hindrance to the operation and maintenance of Distribution lines and threat to the life of Board Staff and public. M/s.Reliance Jio Infocomm Ltd has erected a number of telecommunication poles in close proximity to the electric poles also causing hardship in doing maintenance works by KSEBL staff.

M/s. Reliance Jio Infocomm Ltd, Ernakulam has produced a letter from the Chief Electrical Inspector as per letter read as 4<sup>th</sup> above, in which it was mentioned that they have no objection to use electrically insulated poles near OH lines and the insulation shall be in accordance with relevant safety regulation and standards. The Chief Engineer, Distribution (Central) as per letter read as 5<sup>th</sup> above, had sought clarification from Chief Electrical Inspector on the authenticity of the letter read as 4<sup>th</sup> above, which is not yet responded.

The Chief Safety Commissioner has already issued following directions as per letter read as 6<sup>th</sup> above to the field officers for ensuring safety:

- Give notice to M/s.Reliance Jio Infocomm Ltd for removing their installations in locations having safety issues citing the relevant CEA Regulations.
- 2. Report the cases to District Collector /ADM and the Electrical Inspector quoting the relevant safety regulations.
- 3. The following regulations may be referred while taking up the matter and quoted appropriately.

- i. Section 68(5) of Electricity Act 2003.
- ii. Regulations (60) & (61) of Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations 2010.
- Regulations 63 & 69 of Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations 2010 to be read concurrently.
- iv. Any other statute or regulations regarding safety.

The Corporation of Kochi had convened a meeting of all utilities and cable operators to remove all low lying cables from the road and action plan is charted out. KSEBL is cooperating with the Corporation in this regard. The drive is on account of the Hon'ble High Court intervention.

The matter was placed before the Full Time Directors as per note read as 7<sup>th</sup> above. Having considered the matter in detail, the Full Time Directors in the meeting held on 01.08.2022 resolved to accord sanction for the following:

- 1. To organize a drive to remove all unauthorised cables and to standardize the authorised cables throughout the State by giving awareness through Mass Media and Social Media and to authorize Chief Public Relation Officer to arrange.
- To authorise Executive Engineers of Electrical Divisions to grant a period of 3
  weeks to all authorized users to standardize their installations by providing
  adequate clearance to ground and to electric lines.
- 3. To authorise the Executive Engineers of Electrical Divisions to approach the local bodies and to offer to participate in this special drive to remove all low lying cables and unauthorized cables in view of the Hon'ble High Court Order as followed in the Corporation limits in Kochi.
- 4. To authorise the Chief Engineer (IT, CR & CAPS) to develop a Mobile Application to link the authorized cable users with geo-co-ordinates of poles.
- 5. To take up with the Government regarding the safety concerns on installation of poles and cables near electric poles and to request to issue strict directions to Local Bodies, PWD, NH authorities for ensuring compliance of regulations and safety measures mentioned in the Central Electricity Authority (Measures relating)

to Safety and Electric Supply) Regulations, 2010, while permitting or executing agreements for laying cables along the roads.

Orders are issued accordingly.
