ORDER

The District Hospital Aluva is an existing HT consumer with consumer code 20/8356. The Deputy Chief Engineer, Electrical Circle, Perumbavoor, as per the letter read 1st above, has reported that the Superintendent, District Hospital Aluva has requested for separate LT connection to the new oxygen plant having connected load of 63.84kW, constructed in connection with the Covid Centre. The connection to this oxygen plant can be given from the same 250kVA transformer from which the connection to the Covid centre is given.

A demand letter for Rs.91,140/- was issued to the consumer. This includes ECSC charges of Rs.27,140/- and CD of Rs 64,000/-. The Superintendent of District Hospital has requested for waiving security deposit for Rs.64,000/-, due to shortage of fund.

Considering the urgency of the matter, the Director(Distribution & IT), as per note read as 3rd has recommended to collect 20% amount of Security Deposit initially calculated from the applicant, as the Security Deposit can be collected as Additional Cash Deposit amount based on the actual consumption.

Having considered the matter in detail, the Full Time Directors in the meeting held on 01.10.2021 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Perumbavoor to effect LT service connection to the oxygen plant of Govt. Hospital, Aluva after

collecting 20% of the initially calculated Security Deposit and realizing all other charges and after ensuring all safety aspects, as a special case.

Orders are issued accordingly.
