ORDER

In connection with the General Election to the Local Self Government Institutions in the State, Government of Kerala, vide order read above, have declared the polling days, as detailed below, as Public Holidays for Public Offices and Educational Institutions, holidays to those institutions governed under Negotiable Instrument Act and a paid holiday for all Government/Quasi Government and Commercial Establishments in the districts where election to be conducted on such days.

08.12.2020	Tuesday	Thiruvananthapuram, Kollam, Pathanamthitta, Alappuzha and Idukki
10.12.2020	Thursday	Kottayam, Ernakulam, Thrissur, Palakkad and Wayanad
14.12.2020	Monday	Malappuram, Kozhikode, Kannur and Kasaragod

Employees including casual workers, who are residents of the above districts and registered as electors in a constituency under the concerned districts, but serving/employed outside his native district, have to be given the benefit of paid holiday on the day of Poll in their native districts.

As ordered by the Chairman & Managing Director, vide order read 2nd above, the G.O has been adopted for implementation in the KSEB Limited and the matter was placed before the Full Time Directors, vide note read 3rd above, for ratifying the Office Order read 2nd above.

Having examined the matter in detail, the Full Time Directors' meeting held on 16.12.2020 has resolved to ratify the adoption of the Government Order read 1st above, for implementation in the KSEB Ltd vide Office Order read 2nd.
