## **ORDER**

The work of Pallivasal Extension Scheme (2x30 MW) – Balance Civil works of tunnel, surge shaft, pressure shaft, penstock, power house and allied works was awarded to M/s. Anchor Structurals–DSE–SSIPL Consortium, Eloor House, Kolenchery, Ernakulam at their quoted amount of ₹48,34,11,157/-. The official date of commencement and completion of work as per agreement read as 2<sup>nd</sup> above are 12.08.2019 and 11.10.2021 respectively. The work has achieved a physical progress of 72%.

The time of completion of work was extended up to 31.05.2022 as per the BO read as  $3^{rd}$  above.

The Deputy Chief Engineer & PM, PES with full powers of Chief Engineer as per note read as  $6^{th}$  above has reported that even though the contractor utilized the extension of time effectively, the work could not be completed due to various unavoidable reasons.

The reasons for delay reported are due to (i) time delay in forming the tunnel to the required line and level after clearing the undercuts (left out by the previous contractor) which consumes more time than the original tunnel driving job, additional mucking etc. which were unpredictable while preparing the estimate, (ii) Covid pandemic third wave which seriously affected manpower resources and transportation of materials, (iii) unprecedented heavy rains and loose soil conditions at site, (iv) balance works of the Power House like switch yard foundation works, road works, flooring works, painting works etc. can be completed only in tandem with the completion of E&M works.

The contract for E&M works is for a period of one year up to January, 2023.

The contractor as per letter read as 4<sup>th</sup> above has requested for extension of time of completion of work up to 31.12.2022 and submitted a revised micro schedule for the work.

The Project Monitoring Committee held on 22.07.2022 has decided to recommend to the Board to extend the time of completion of the work up to 31.12.2022 without any financial commitment on either side.

The Deputy Chief Engineer & PM, PES as per the note read as 6th above has also requested to grant time extension for the contract period of the subject work up to 31.12.2022 without any financial commitment on either side.

The matter was placed before the Full Time Directors as per note read as 7<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors resolved to accord sanction for extending the time of completion of the contract with M/s. Anchor Structurals–DSE–SSIPL Consortium for the execution of the work of "Pallivasal Extension Scheme (2x30MW) - Balance Civil Works of Tunnel, Surge Shaft, Pressure Shaft, Penstock, Power House and Allied Works" up to 31.12.2022 without any additional financial commitment on either side.

Orders are issued accordingly.
