## **ORDER**

KSEBL has identified certain locations for cost-effective Pumped Storage Schemes (PSP). For going ahead with the proposals, draft Feasibility Study Reports (FSR), Detailed Project Reports (DPR) etc are to be prepared. The preparation of the above documents are to be carried out through competent agencies in the field which are to be selected on competitive bidding. Several Governmental agencies viz., NHPC, NTPC are approaching KSEBL with their offer to carry out the preparation of Pre-feasibility Report (PFR) and Detailed Project Report (DPR) and other connected works of Pumped Storage Schemes. The Chief Engineer (Civil-Investigation & Construction Central) as per the note read as 6th above has requested a decision in this regard.

The matter was placed before the Full Time Directors as per the note read as 7<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 28.09.2022:

Resolved to accord sanction to the Chief Engineer (Civil-Investigation & Construction Central) to proceed with the invitation of Competitive Bidding for the "Preparation of Pre-feasibility Report (PFR) after scientifically assessing the possibility and shortlisting the feasible sites by KSEBL for the Pumped Back Storage Scheme proposals.

Further resolved that the pre-feasibility and DPR preparation shall be done in two stages and only in feasible sites the DPR to be prepared within shortest time.

Orders are issued accordingly.
