The Advocate appointed as Standing Counsel shall safeguard the interest of the KSEB Limited. In case of any default, the Counsel shall be liable to pay the KSEB Limited, even after he ceases to be the

Standing Counsel, damages equal to the loss or injury incurred or sustained by the KSEB Limited as per the Board Order read above.

The allocation of case files to the new Counsel shall be arranged by the Deputy Chief Engineers concerned through the Nodal Officer (litigation) attached to their offices, on instruction from the office of the Legal Adviser & Disciplinary Enquiry Officer, KSEB Limited.

It is further resolved to disengage Smt. Jaisy. T.J, Roll No. K/1416/2000 as Standing Counsel of KSBE Ltd at Kollam. The Nodal Officer (litigation) concerned shall ensure proper handing over of the case files.
