## ORDER

The Deputy Chief Engineer (PED) with full powers of Chief Engineer reported that the Chinnar Small Hydro Electric Project (24MW/76.45MU) - Phase II has been awarded to M/s PGCCPL-Aryacon-FEPL Consortium and agreement read as 1<sup>st</sup> above was executed. The period of completion of the subject project is two years and additional time of seven months has been granted for conducting fresh model test as per letter read as 2<sup>nd</sup> above. The E&M contractor, M/s. Flovel Energy Private Limited, Haryana has started submitting various preliminary documents including Power House layout, switchyard layout, single line diagram, micro schedule, vendor list, etc. for approval. M/s Flovel shall submit various design related documents, material approval, calculations, technical data, test reports, etc. in due course. The approval of these documents has to be carried out after due verification in a time bound manner for timely completion of the project. This work can be timely completed by availing the services of KSEBL officials having vast expertise in Generating stations, Electrical and Mechanical systems, Protection and Control systems, SCADA systems etc. The names of below mentioned officers have been recommended by the Deputy Chief Engineer (PED) with full powers of Chief Engineer considering their experience in the relevant areas associated with similar projects.
