ORDER

Sanction was accorded as per B.O.for an estimate amounting to Rs.28,92,000/- for imparting training on the first stage equipment, through the OEM contractor, M/s GEPIL. The work has to be awarded to M/s GEPIL and implemented under the RDSS scheme.

As the work order has to be placed and the payment has to be made on completion of the training, the Chief Engineer (Generation) as per the letter read as 2nd above has requested for the details of Account head of the RDSS scheme for charging the expenditure and proceed with the training. Also requested about the accounting procedure to be adopted for making payments to the contractor under the RDSS scheme, as envisaged.

In this matter, Director (Generation Electrical) has recommended that either we have to proceed with the training and implemented under RDSS scheme as envisaged in the B.O and the account head details may be communicated to the field office or the expenditure may be charged under the head Repiars and maintanence of the Station.

The matter was placed before the Full Time Directors as per the Note read as $3^{\rm rd}$ above.

The Full Time Ditectors in the meeting held on 12.10.2022 has resolved to charge the expenditure of the training under RDSS as decided earlier.

Further resolved to identify more Officers for the training and the trained Officers

shall impart training to others. Director (Generation-Electrical) shall submit a training plan.

Further resolved that if there is any delay in RDSS funds, payment shall be charged under appropriate Head of Account and later streamlined under RDSS.

Orders are issued accordingly.
