Special scheme for regularising connected load – further extending the scheme period till 31st May 2021 – Sanctioned– Orders issued.

ORDER

KSEBL, as a part of Ease of Doing Business reforms had extended the facility for revising connected load for all LT consumers based on self declaration as per BO read as 1st above, wherein the LT consumers under all categories were given the opportunity to regularise their connected load from 01.08.2019 to 31.10.2019. This was further extended up to 31.12.2019 as per BO read as 2nd above and thereafter until 30th June 2020 as per BO read as 3rd above and further extended upto 31st December 2020 as per BO read as 4th above.

As per the scheme, for regularising the connected load, the applicant need not pay application fee, testing fee or additional security deposit. However these consumers will have to pay for network enhancement if the declared new load demands it or if there is change in voltage level and will be liable to pay additional security deposit, if so required during the review at the first quarter of each financial year as envisaged in the Supply Code Regulations. In cases where objection exists from any statutory legal authority, the load regularisation in such cases shall be taken up under this Scheme only if the objection has been cleared.

The Chief Engineer (Distribution South) as per letter read as 5th above, has reported that special drive was conducted at section level in Southern region to make consumers aware of the scheme by approaching them at their premises, which resulted in increase in connected load of the registered consumers. It has been further reported that around 70,082 consumers applied for the load regularisation till 31.12.2020 and 151.476MW load was regularised and thereby an estimated increase in

fixed charge of Rs.34.62 lakh/month was achieved in Southern region. It was also reported that some of the consumers could not avail the benefit owing to the restrictions imposed on public transport to contain the outbreak of COVID -19 pandemic and due to local body elections conducted during December 2020 and has requested to extend the above scheme till 31st March 2021, so that maximum benefit would be availed by the left out consumers. The matter was placed before the Full Time Directors as per note read as 6th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 28/01/2021,

1. Resolved to extend the facility for revising connected load for all categories of LT consumers based on self declaration announced vide BO read as 4th above up to **31.05.2021** subject to the condition that in cases where objection exists from any statutory legal authority, the load regularisation, in such cases shall be taken up under this Scheme only if the objection has been cleared.
2. Further resolved to entrust the CPRO/Chief Engineer (IT & CR) to give wide publicity for the above mentioned scheme.


