ABSTRACT

State Support schemes under Innovation & Escot fund for the Financial Year 2022-23 - Carrying out the transformer standardisation works under Electrical Circles Haripad and Sreekantapuram in anticipation of recoupment from the Government - Sanctioned - orders issued.

ORDER

The Director (Transmission, System Operation, Planning and Safety) as per note read as 2nd above had sought proposals to be included under the Innovation & Escot fund of the Government for the year 2022-23.

Accordingly, a proposal for standardising 100 transformer stations (50 transformers each under Sreekandapuram and Haripad Circles at a cost of Rs 1.76 Crores) was furnished to the Office of the Deputy Chief Engineer (Planning) as per note read as 3rd above.

As per B.O. read as 4th above, it was decided to take up the proposal (along with other proposals totaling to Rs 34.36 Crore), with the Government of Kerala for obtaining administrative sanction.

The Government of Kerala has issued Administrative sanction as per G.O. read as 5th above.

Since utilisation certificate has to be furnished to the Government of Kerala for release of fund, the Director (Distribution, $\Pi\&$ SCM), suggested that sanction be given for carrying out the work for which administrative sanction

has been accorded by the Government, utilising KSEBL's fund, in anticipation of recoupment from the Government of Kerala and that the work can be included under the Innovation and Escot fund of the Government of Kerala for the year 2022-23.

The matter was placed before the Full Time Directors as per the note read as 6^{th} above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 30.11.2022 resolved to accord saction to proceed with the work of standardisation of 100 transformer stations, 50 each under Haripad and Sreekantapuram Electrical Circles in anticipation of recoupment of the Government of Kerala fund amounting to Rs.1.76 Crores sanctioned for the purpose.

Furter resolved to authorise the Deputy Chief Engineers of Haripad and Sreekantapuram Circles to carry out the work and submit the utilisation certificate by the end of February 2023 positively for claiming the funds from the Government of Kerala.

Further resolved to direct the Chief Engineer (IT,CR & CAPs) to make necessary modification in the Samagra software to facilitate Haripad and Sreekantapuram Electrical Circles to execute the work under the head 'Innovation & Escot fund'.

Orders are issued accordingly.
