## **ORDER**

The Muncipal Chairperson, Kayamkulam Municipality has submitted a representation before the Hon'ble Minister for Electricity stating that the Kayamkulam Taluk Hospital under Kayamkulam Municipality is having electricity charge arrears for existing LT connection amounting to Rs.25,57,983/- and KSEBL had intimated that a new HT connection to the premise can be effected only on payment of arrears.

The Muncipal Chairperson, Kayamkulam Municipality has reported that due to non availability of HT connection, the inauguration of the new Children and Women block, ICU, lifts could not be carried out and that steps were taken for obtaining funds from the Government and assured that arrears shall be cleared off on receipt of funds and requested intervention of the Hon'ble Minister for Electricity for smooth running of the hospital.

Considering the urgency in the matter, the Director (Distribution ,IT SCM, REES & Soura) as per letter read as 2<sup>nd</sup> above, has accorded sanction to the Deputy Chief Engineer, Electrical Circle, Haripad, to effect the HT connection to the Kayamkulam Taluk hospital after obtaining an undertaking to the effect that the arrears will be settled within two months.

The matter was placed before the Full Time Directors as per the note read as 3<sup>rd</sup> above for ratification.

Having considered the matter in detail, the Full Time Directors in its meeting held on 18.05.2023, resolved to ratify the action of the Director (Distribution, IT SCM, REES &

Soura) to accord sanction to effect the HT connection to the Kayamkulam Taluk hospital after obtaining an undertaking to the effect that the arrears will be settled within two months.
