ORDER

The National Highway Authority of India (NHA) has requested for utility shifting along the side of the National Highway 66 in Electrical Sections, Kuthiyathodu and Aroor under Electrical Division, Cherthala in connection with the construction of Elevated Highway Corridor (fly over) from Thuravoor Thekku to Aroor under Bharatmala Pariyojana project for maintaining statutory clearances as per CEA regulations with electrical lines.

The total length of highway for which utilities are to be shifted is about 13.4km. The portion in Electrical Section, Kuthiyathode is 6.5 km from Thuravoor to Kannukulangara and in Electrical Section Aroor is 6.9 km from Kannukulangara to Aroor Bypass and a part of Aroor Edakochi road.

The Chief Engineer, Distribution (Central) as per letter read as 3rd above had forwarded an estimate amounting to Rs.69,37,92,288/- (Rupees Sixty Nine Crore Thirty Seven Lakh Ninety Two Thousand Two Hundred And Eighty Eight only) and requested sanction for the work of shifting of electrical utility from the existing right of way to utility corridor for the above portions.

An abstract report on the estimate for the utility shifting is cited below:

As per the delegation of powers, Chief Engineer is delegated with power for granting Administrative and Technical Sanction upto Rs.10 Crore, for deposit works to be carried out by KSEBL after collecting cost from the applicant or works being carried out by beneficiary themselves under the supervision of KSEBL's officials after collecting supervision charges. KSEBL as per the BO read as 1st above,

accorded sanction to restrict the supervision charges to 2.5% of the total approved cost in case of utility shifting for National Highway Authority of India (NHAI) projects.

The Chief Engineer, Distribution (Central) as per letter read as 3rd above has requested sanction for carrying out the subject work of utility shifting for National Highway Authority of India (NHAI) projects from Aroor to Thuravoor.

The matter was placed before the Full Time Directors as per the note read as 4th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 27.03.2023, resolved to accord sanction to the Chief Engineer, Distribution (Central), for granting Administrative Sanction after detailed scrutiny of the estimate, for shifting of utilities in connection with the construction of 6 lane Elevated Highway along with the development of existing 4 lane road at ground level from Aroor to Thuravoor stretch under Electrical Circle, Alappuzha, for National Highway Authority of India (NHAI) projects.

Orders are issued accordingly.
