<u>ORDER</u>

M/s. Leprosy Sanatorium, Nooranadu, a Government Hospital is presently a deemed HT consumer(LCN 24/3700) under Electrical Section, Charummoodu and Electrical Circle, Haripad. The Deputy Chief Engineer, Electrical Circle, Haripad as per the letter read as 2nd above has reported that an application for HT connection to the extend of 300 kVA power was submitted by the consumer.

The District Collector, Alappuzha as per the letter read as 1st above, has assured that urgent action will be taken to obtain fund from Government to remit the arrears and that KSEBL may sanction the estimate for drawing HT line. The Deputy Chief Engineer, Electrical Circle, Haripad as per letter read as 2nd above has sought sanction for providing HT connection to M/s.Leprosy Sanatorium, Nooranadu based on the above assurance.

The Special Officer, Revenue as per the note read as 4th above has reported that, the subject consumer is billed under HT II(A) for demand charge and LT VI(A) for energy charges with contract demand 100kVA as per BO dated 24.03.2017. The low voltage surcharge levied is Rs.34,19,466.20/- as on February 2023 and the total arrear amounts to Rs.1,53,97,984/- as on February 2023.

Meanwhile, the Principal Secretary to Government, Health, Family Welfare & Ayush Department, Government of Kerala as per D.O letter read as 3rd above has requested to provide HT connection to the Sanatorium, pending the dues and also to furnish the details of arrears for taking up with Finance Department for in time settlement of dues.The matter was placed before the Full Time Directors as per the note read as 5th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 30.03.2023,

1. Resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Haripad to proceed with the request of providing HT connection to M/s.Leprosy Sanatorium, Nooranadu, a

deemed HT consumer (LCN 24/3700) in Electrical Section, Charummoodu as a special case, based on the assurance of the Hon'ble District Collector, Alappuzha and the Principal Secretary to Government, Health, Family Welfare & Ayush Department, Government of Kerala and considering the nature of service rendered by the Institution.

- Further resolved to authorize the Special Officer, Revenue, to furnish the details of arrears of M/s.Leprosy Sanatorium, Nooranadu to the Health Departement for taking up with the Finance Department for settlement of dues.
- 3. Further resolved that a communication shall be given to Health Department (Principal Secretary /Director of Health Services) to set off arrears in time bound manner.
