ORDER

The Chief Engineer Distribution (Central) as per letter read as 3rd above, has forwarded the estimate for shifting of utilities in connection with the development of Moothakunnam to Edappally stretch of National Highway - 66 passing through Electrical Sections under two Electrical Divisions, Ernakulam and North Paravur under Electrical Circle, Ernakulam and requested consent for issuing sanction for carrying out the subject work. The estimate amounts to **Rs.53,09,82,811/-** (Rupees Fifty Three Crore Nine Lakh Eighty Two Thousand Eight Hundred and Eleven Only).

The estimate includes shifting of KSEB utilities of two Electrical Sections under Electrical Division, Ernakulam viz. Cheranallur & Edappally and five Electrical sections under Electrical Division, North Paravur viz. Moothakunnam,Vadakkekara, Ezhikkakara, North Paravur and Varappuzha.

The estimate amount under each Section is shown below.

The estimate for utility shifting is prepared in accordance with the following criteria in all Sections.

1. It is proposed to lay cable trenches on both sides and utility crossing trenches in every 500 meters, for maintaining power supply to existing consumers on both sides of the NH.

This estimate includes the amount for providing cable ducts of inner size 1m x 0.7 m for laying HT UG cables.

2. All dismantled reusable materials during the execution of the shifting work are included in the estimate. The cost of dismantled items is deducted as per G.O. read as 2nd above.
3. The Supervision charges @ 2.5% is taken for the works as per B.O. read as 1st above.

As per delegation of power of Executive Officers of KSEBL, (B.O.(DB) No. 449/2022 (PLNG-AEE2/2022/31) TVPM dated 26.05.2022, the Chief Engineer is empowered for granting administrative and technical sanction up to Rs.10 Crore, for deposit works to be carried out by KSEBL after collecting cost from the applicant or works being carried out by beneficiary themselves under the supervision of KSEBL's officials after collecting supervision charges. For works > 10Crore, Consent of FTD to be obtained.

Accordingly the matter was placed before the Full Time Directors as per the note read as 4th above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 01.08.2022, resolved to accord sanction to the Chief Engineer (Distribution Central) for granting Administrative Sanction after detailed scrutiny of the estimate for the Deposit work in connection with the widening of National Highway 66-Moothakunnam to Edappally stretch coming under Electrical Circle Ernakulam.

Orders are issued accordingly.
