ORDER

The Assistant Engineer, KWA, Project Division, Kottayam applied for enhancement of Contract demand from 303kVA to 498kVA in favour of M/s KWA, Raw Water Pump House (LCN 35/6840) under Electrical Section, Ettumanoor under KIIFB Project and necessary fee was remitted at the Electrical Section office on 01/09/2020.

The Executive Engineer, Electrical Division, Vaikom prepared an estimate amounting to ₹15,70,000/- for extending uninterrupted power supply by rearranging 11kV supply from 110kV Substation, Ayarkunnam, 66kV Substation, Ettumanoor and 66kV Substation, Gandhinagar. The estimate included erection of a PSC four pole DP structure, constructing 650m 11kV OH line using Raccoon conductor, 450m LT line renewal with HT poles and allied HT/LT line work, drawing 300m HT ABC of 3x120+1x95sqmm and laying 30m 11kV XLPE UG cable.

The Special Officer, Revenue, Thiruvananthapuram, reported as per letter dated 23/12/2020 that the consumer was having current charge arrear of ₹1,30,25,630/-

(Rs. One Crore Thirty Lakh Twenty five Thousand Six Hundred and Thirty Only) pending realization. Subsequently notice was issued to M/s KWA for remitting the said arrear, but the Executive Engineer, M/s KWA as per letter dated 04/01/2021 intimated that the fund request of the arrear has been forwarded to their head office FM & CAO and the arrear amount would be remitted as soon as the fund is received from head office.

The Executive Engineer, KWA, Project Division, Kottayam informed that the said work is a KIIFB (2017-18) funded Drinking Water Project.

The Deputy Chief Engineer, Electrical Circle, Kottayam, as per letter read as 2nd above, sought directions on the request of the HT consumer (LCN 35/6840) under Electrical Section Ettumanoor, for load enhancement.

As per KESC 2014 Regulation 99(4), the application for enhancement of load shall not be considered if the consumer is in arrears of payment of the dues payable to licensee. As per BO read as 1st above, the Chief Engineers (Distribution) were authorized to enhance the contract demand of HT service connections of M/s KWA on receipt of application and after collecting required deposit and the 'arrears from 1/1/2019'.

The matter was placed before the Full Time Directors as per note read as 7th above, after getting the up to date arrears of the consumer, reported by the Special Officer, Revenue as per note read as 4th above as ₹2,62,50,965/- (Two Crore, Sixty two Lakh, Fifty thousand, Nine Hundred and Sixty Five only), for the period June 2019 to Sep 2021, including up to date interest of ₹39,27,942/-.

Having considered the matter in detail, the Full Time Directors in the meeting held on 17/09/2021,

Resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Kottayam, to process the application from M/s KWA Raw Water Pump House (LCN 35/6840) under Electrical Section, Ettumanoor (with a pending current charge arrear of ₹2,62,50,965/- (Two Crore, Sixty two Lakh, Fifty thousand, Nine Hundred and Sixty five only), for the period from June 2019 to Sep 2021, including up to date interest of ₹39,27,942/-), for enhancing their contract

demand from the existing 303kVA to 498kVA, considering that the said enhancement work comes under KIIFB funded (2017-18) drinking water project in Ettumanoor, as a special case.

Orders are issued accordingly.
