### ORDER

The Government of Kerala (GoK) sanctioned a special compensation package for the construction of Pugalur-Thrissur HVDC line (Kerala portion) and Thrissur-Kochi LLO line as per the orders read as 1<sup>st</sup> and 2<sup>nd</sup> above. The share of PGCIL, KSEBL and GoK towards the Tower Standing Area compensation and Line corridor compensation (RoW) are clearly defined in the package. KSEBL has been remitting its share of compensation based on the DVS approved by the District Collector, Palakkad and forwarded by the Special Tahsildar, LA, Powergrid, Palakkad. An amount of Rs.3,76,21,833/- has been remitted by KSEBL so far towards the compensation.

The Government of Kerala is yet to release its share of compensation to the LA authorities and has ordered as per G.O read as 7<sup>th</sup> above that the payment of compensation on part payment basis shall be commenced subject to the willingness of land owners. As per the order, those who are not willing to accept part payment have to wait till the Government share is released. Compensation @ 68.75% will be given to those who are willing to accept part payment and whose compensation claim has been approved.

The Executive Engineer, Transmission Division, Chittur who has been assigned the task of coordinating the compensation disbursement and allied matters from KSEBL side, reported

as per letters read as 8<sup>th</sup> and 9<sup>th</sup> above that the Special Tahsildar, LA, Powergrid, Palakkad, has submitted additional Detailed Valuation Statements (DVS) approved by the District Collector, Palakkad with respect to Line Corridor compensation, amounting to Rs. 1,80,45,560/- for 234 cases (land owners). The details are as below:-

The Executive Engineer, Transmission Division, Chittur requested remittance of the KSEBL share of Rs. 1,80,45,560/- to the account of the Special Tahsildar, LA, Powergrid, Palakkad, Canara Bank, Sulthanpetta (A/c No. 0812101071441, IFSC code - CNRB0000812).

The matter was placed before the Full Time Directors for sanction as per note read as 10<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors, in the meeting held on 04.11.2022 resolved to accord sanction to transfer an amount of Rs. 1,80,45,560/- (Rupees One crore eighty lakhs forty five thousand five hundred and sixty only) to the account of the Special Tahasildar, LA, Powergrid, Canara Bank, Sulthanpetta, Palakkad (A/c No. 0812101071441, IFSC code - CNRB0000812) as the share of KSEBL towards the compensation (ex-gratia and displacement) for Line Corridor for the 234 cases (land owners) for which DVS has been approved by the District Collector.

Further resolved to authorize the Financial Adviser to transfer the amount of Rs. 1,80,45,560/- (Rupees One crore eighty lakhs forty five thousand five hundred and sixty only) to the ARU of Transmission Circle, Palakkad in the account head "Compensation for Pugalur-Thrissur HVDC line".

Further resolved that the amount shall be transferred as and when due for disbursement.

Orders are issued accordingly.
