ORDER

In order to facilitate evacuation of power from the upcoming projects such as 400 kV Substation, Karinthalam under construction by M/s UKTL under TBCB route and 220/110kV MCMV lines under construction by Trangrid, proposal for constructing a new 220 kV substation at Vidyanagar by upgrading the existing 110 kV substation is formulated with the following components.

- Installation of 2x100 MVA 220/110kV Transformers
- Installation of double bus bar with one bus coupler, 2 transformer bays, 2 feeder bays
- Inter-connection of two new transformer bays to the existing 110 kV bus with double bus arrangement
- Construction of 1 km 220 kV DC line from the Transgrid MCMV terminal tower to Vidyanagar substation compound.

The DPR Committee approved the proposal as per letter read as 1st above. The Chief Engineer (Trans. North) as per letter read as 2nd above requested Administrative sanction for the proposal at an estimate amount of Rs. 31 crores, which is prepared based on the latest cost data, DSR 2018 and latest tenderec works.

The matter was placed before the Full time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 04.11.2022, resolved to accord Administrative Sanction for the estimate amounting to Rs.31 crores (Rupees Thirty one crores only) for the work "Construction of new 220kV Substation at Vidyanagar in Kasargode district" under Transmission Circle, Kannur.

Orders are issued accordingly.


