ABSTRACT

Enhancement of kilometer ceiling limit of the vehicles attached to PET Subdivision, Thiruvananthapuram, Communication Subdivision, Edamon, Communication Subdivision, Areekode, Meter Testing Subdivision, Kozhikode and Meter Testing Subdivision, Kannur - Sanction accorded - Orders issued.

ORDER

The Chief Engineer (Transmission System Operation) as per letter read as 1st above reported that the hired vehicles attached to Communication Sub division, Areekode, Meter Testing Sub division, Kozhikode and Meter Testing Sub division, Kannur usually exceeds the sanctioned monthly km ceiling limit due to the following reasons:

- The Meter Testing Sub divisions are entrusted with the works of meter testing in substations and solar installation testings. The substations and the area to be covered for the testing of solar installations are scattered under three districts and there is a vast area to be covered for the fulfillment of the targets.
- All the works associated with the commissioning activities of Reliable Communication Project, fine tuning of ADMS system, maintenance works of RTUs and mini RTUs are to be attended by the Communication Subdivisions.

Hence the Chief Engineer (Transmission System Operation) requested to enhance the monthly km ceiling limit of the above Subdivisions as follows:

- 1) Communication Subdivision, Areekode - from 2000 km to 2250 km.
- 2) Meter Testing Subdivision, Kozhikode - from 2000 km to 2500 km.
- 3) Meter Testing Subdivision, Kannur - from 2000 km to 2500 km.

As per letter read as 2nd above, the Executive Engineer in charge, SOC, Thiruvananthapuram reported that the department vehicle attached to PET subdivision, Thiruvananthapuram is usually running excess km beyond the ceiling limit since the jurisdiction of PET subdivision, Thiruvananthapuram is spread over a vast area covering Thiruvananthapuram, Kollam and certain portions of Pathanamthitta districts and the Subdivision is entrusted with the high voltage testing of all yard equipment: under 71 substations spread across the above districts.

Testing includes Routine, Pre-commissioning, Re-commissioning, Commissioning, Trouble shooting and Condition monitoring testing. To execute these works, the PET team had to travel to these stations, which are located too far apart.

Further, the hired vehicle attached to Communication subdivision, Edamon also usually runs excess km because the jurisdiction of this subdivision is spread over Kollam district including Thenmala and the monthly kilometer ceiling limit of the contract vehicle, which is 1500 km per month, is insufficient to execute the various official and technical duties of the officials through the length and breadth of Kollam district.

Hence the Executive Engineer in charge, System Operation Circle, Thiruvananthapuram requested to enhance the monthly km ceiling limit of the above Subdivisions as follows:

- 1) PET Subdivision, Thiruvananthapuram - from 2000 km to 2500 km.
- 2) Communication Subdivision, Edamon - from 1500 km to 2000 km.

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 28.10.2022, resolved to accord sanction for enhancing the sanctioned kilometer ceiling limit of the vehicles attached to the following offices:

- 1) Communication Subdivision, Areacode - 2000 km to 2250 km.
- 2) Meter Testing Subdivision, Kozhikode - 2000 km to 2500 km.
- 3) Meter Testing Subdivision, Kannur - 2000 km to 2500 km.
- 4) PET Subdivision, Thiruvananthapuram - 2000 km to 2500 km.
- 5) Communication Subdivision, Edamon - 1500 km to 2000 km.

Orders are issued accordingly.
