ORDER

KSEBL as per B.O read as 1st above accorded sanction for awarding the work 'Construction of 125km 400kV double circuit line from Wayanad to Kasaragod', a part of the North Green Corridor project to M/s L&T Ltd on Turnkey basis and accordingly the Chief Engineer, TransGrid has issued Work Order and executed the Agreement with M/s L&T Ltd on 31.05.2022.

For ease of execution of the works and completion of the project in time bound, it is proposed to divide the entire line stretch of 125km into 3 portions among the three Transmission Construction Sub Divisions Wayanad, Thalassery and Payyannur. The works include construction of 400kV S/S at Payyampilly (Wayanad), construction of 17km 400kV line in Wayanad District, 78km in Kannur District and 30km in Kasaragod District. The Deputy Chief Engineer I/C, TransGrid suggested functioning of two TC Section Offices at Alakode and Iritty by deploying two Assistant Engineers (Ele) presently working under TG TC Sub Division, Wayanad, now functioning at 220kV S/S compound, Kaniyambetta for effective coordination and supervision of the works. The Deputy Chief Engineer I/C also requested sanction for hiring jeeps with driver for the use of the aforesaid TC sections.

The matter was placed before the Full Time Directors as per the Note read as 4th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 05.09.2022 resolved to accord sanction to form two Transmission Construction Section Offices with headquarters at Alakode and Iritty in Kannur District under TransGrid TC Sub Division, Wayanad by deploying two Assistant Engineers (Ele) presently working under TransGrid TC Sub Division, Wayanad till completion of the Project.

Further resolved to accord sanction to entrust the Deputy Chief Engineer in charge, TransGrid.

- To set up the new TC Section Offices at Alakode and Irity in KSEBL assets to the extent possible and if not available, in rental buildings as per the prevailing norms of KSEBL.
- To engage two jeeps with driver on contract basis for the use of the proposed TransGrid TC Section Offices Alakode and Irity with a monthly limit of 2000km as per the standard conditions prevailing.

Orders are issued accordingly.


