ORDER

KSEBL as per the B.O. read as 1st above accorded sanction to provide service connection to the bunks situated on the road sides functioning as licensees of HortiCorp, throughout the state without insisting for ownership documents as a special case and directed the Chief Engineers (Distribution) to effect service connection to such bunks, after executing an indemnity bond by the applicant that the service connection is liable to be disconnected, if the Secretary of the local body or any other statutory authority requests in writing to disconnect the service connection.

KSEBL as per the B.O. read as 2nd above accorded sanction to extend the benefit granted to the stalls of HortiCorp, to Milma booths situated on road sides also, as a special case, subject to the condition that the service connection is liable to be disconnected, if the Secretary of the local body or any other statutory authority requests in writing to disconnect the service connection.

The Chairman, Kerala State Poultry Development Corporation Ltd., as per the letter read as 3rd above informed that in response to public demand, retail outlets / bunks are being established by KEPCO for selling KEPCO chicken and associated value added products and that while applying for new service connection for newly established retail outlets / bunks, submission of license from local body is being insisted by KSEBL authorities. The Chairman, M/s KEPCO, requested for waiver of submission of license along with application for new service connection in line with previous Board decision granting

waiver of ownership documents for new service connections to HortiCorp bunks and Milma booths.

The matter was placed before the Full Time Directors as per the note read as 5th above.

Having examined the matter in detail, the Full Time Directors in its meeting held on 26.11.2022 resolved to accord sanction to extend the concession granted to HortiCorp bunks and Milma booths, to KEPCO sales outlet bunks throughout the state also, as a special case, considering the request of the Chairman, Kerala State Poultry Development Corporation Ltd .

Further resolved to direct the Chief Engineers (Distribution) to effect service connection to such bunks without insisting for ownership documents, on execution of an indemnity bond by the applicant that the service connection is liable to be disconnected, if the Secretary of the local body or any other statutory authority requests in writing to disconnect / dismantle the service connection.

Further resolved to modify the Board order read as 4th above to this extent.
