ORDER

The Deputy Chief Engineer, Electrical Circle, Perumbavoor, as per letter read as 1st above, has intimated that the Superintendent of Government District Hospital, Aluva, an existing HT consumer with consumer code 20/8356 has requested for a separate LT connection to the new Covid Block. Subsequently, a demand letter for Rs. 1,59,993/- towards the cost of work for constructing 10m 11kV OH line, erecting one number of PSC DP structure and installing 250kVA transformer (supplied by party) was issued by the Assistant Engineer, Electrical Section, Aluva Town on 09.03.2021 The applicant had remitted the amount on 22.03.2021 and all the works including erection of 250kVA transformer are completed on the next day itself.

Presently, Online application of the hospital authorities for new service connection with connected load of 116.479kW and contract demand of 91kVA was received on 24.03.2021. The demand for remitting Security Deposit of Rs.1,17,000/and ECSC of Rs.23,000/- + GST was issued by the Assistant Engineer Electrical Section Aluva Town on 28.03.2021. The applicant has transferred the ECSC amount of Rs.23,000/- and GST to KSEBL Bank Account on 31.03.2021. The Superintendent of the Government District Hospital Aluva has submitted a request for waiving of Security Deposit for Rs.1,17,000/- considering the emergency situation.

Hence, the Deputy Chief Engineer, Electrical Circle Perumbavoor has sought necessary direction on whether the LT service connection to the Covid Block can be effected without insisting the remittance of the Security Deposit considering its social aspects.

Considering the urgency of the matter, it is recommended that a 20% amount of Security Deposit initially calculated may be collected from the applicant, as the Security Deposit can be collected as Additional Cash Deposit based on the actual consumption.

The matter was placed before the Full Time Directors as per the note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 08.04.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Perumbavoor to effect LT service connection to the new Covid block of Government District Hospital, Aluva after collecting 20% of the initially calculated Security Deposit and realizing all other charges.

Orders are issued accordingly.
