ABSTRACT

Enhancement of contract demand from 100 kVA to 350 kVA of M/s HPCL (LCN:15/1535) under Electrical Section Eranhikkal - Ratification - Orders Issued.

ORDER

The Deputy Chief Engineer, Electrical Circle Kozhikode as per the letter read as 1st above reported that M/s HPCL, Elathur (LCN 15/1535) under Electrical Section, Eranhikkal has submitted an application for the enhancement of connected load from 322 kW to 807 kW and contract demand from 100 kVA to 350 kVA.

As per the report of the Special Officer Revenue, the consumer is having an amount of Rs 47,78,010/-as disputed amount pending realization and not having any current charge arrear. The available Security Deposit is Rs 2,52,070/-.

The LA and DEO as per the note read as 2nd above remarked that taking into account of the stay on recovery of disputed amount as ordered by the Hon'ble High Court, the amount in dispute cannot in strict sense, be termed as 'dues' as mentioned in Regulation 99(4) of the Supply Code 2014. As such, the application for the consumer for enhancement of the Contract Demand may be proceeded with.

The Deputy Chief Engineer, Electrical Circle Kozhikode requested to issue direction to process the application for the enhancement of connected load from 322 kW to 807kW and contract demand from 100kVA to 350kVA in favour of M/s HPCL, Elathur (LCN 15/1535) under Electrical Section Eranhikkal, as an appeal on the disputed amount is under consideration of Appellate Authority.

The matter was placed before the Full-Time Directors as per the note read as 3rd above vide Agenda Item No. 130/3/22 and it was deferred for reviewing agreement aspects.

Meanwhile, the Kerala State Electricity Appellate Authority delivered its Order on 13.04.2022, set asiding the final assessment order No. DB01/ESD/WHL/AEE/FINALASSESSMENT/01/20-

21/46 dtd 05.10.2020 issued by the Assistant Executive Engineer, Electrical Sub Division, WestHill for an amount of Rs 72,46,028/-.KSEBL as per the Office Order (DF) No.794/2022(LAW1/5613/2020) dated 13.06.2022 has decided to challenge the order of the Kerala State Electricity Appellate Authority by filing a Writ Petition before the Hon'ble High Court.

Considering the request of the consumer for connecting the additional load at the earliest, the Deputy Chief Engineer, Electrical Circle, Kozhikode was directed to process the application for enhancement of Connected load & Contract Demand after obtaining an undertaking from the Consumer.

The matter was placed before the Full Time Directors as per the note read as 6th above for ratification.

Having examined the matter in detail, the Full Time Directors in the meeting held on 26.09.2022 resolved to ratify the action of giving direction to the Deputy Chief Engineer, Electrical Circle, Kozhikode to process the application of M/s HPCL, Elathur (LCN 15/1535) under Electrical Section Eranhikkal for the enhancement of connected load from 322 kW to 807 kW and contract demand from 100 kVA to 350 kVA after obtaining an undertaking from the consumer on the payment of disputed amount to KSEBL, as an appeal filed by KSEBL is pending before the Hon'ble High Court of Kerala.

Orders are issued accordingly.
