### **ORDER**

The Deputy Chief Engineer, Electrical Circle,Pathanamthitta as per letter dated 06.07.2022 reported that as per the minutes of the meeting held on 21.08.2017 at the chamber of Additional Chief Secretary- Industries and Power, Government of Kerala, KSEBL was directed to install 2 additional transformers of 250 each kVA at the KINFRA Industrial Park, Kunnamthanam on 50-50 cost sharing basis after receiving power requirement from KINFRA.

Now, the Assistant Manager of KINFRA reported that their power requirement is 1000 kVA. Following this, KINFRA remitted the power allocation fees of Rs.23,612/- on 29.06.2022.

As per letter read as 2<sup>nd</sup> above, the Deputy Chief Engineer, Electrical Circle, Pathanamthitta reported that, the total cost for providing additional 1000 kVA power by installing 4 Nos. of 250 KVA transformers for distribution at Kunnamthanam KINFRA park is Rs 20,93,145/-(Rupees Twenty Lakh Ninety Three Thousand One Hundred and forty Five only).

The Secretary, Power Department in the meeting held on 17.06.2019, has issued a general direction that, 'the cost sharing model of additional infrastructure of industrial parks will be taken up on a case to case basis'.

The Deputy Chief Engineer, Electrical Circle, Pathanamthitta has requested to issue sanction orders for the installation of these additional transformers on a 50:50 cost sharing basis with KINFRA.

The Financial Advisor, KSEBL as per the note read as 4<sup>th</sup> above remarked that several Board orders regarding the execution of certain works of KINFRA on cost sharing basis were issued by the Board on the basis of the minutes of meeting with the Secretary, Power Department in which it was specified that the transformers shall be under the ownership of KSEBL and KSEBL shall have the right to give further connection from the transformers in future without NOC from KINFRA. Similar condition shall be made applicable in the subject case also. Also, GST is to be collected on the cost borne by KINFRA and GST Invoice(B2B) is to be issued from the respective ARU.

The matter was placed before the Full Time Directors as per the note read as 5<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 10.10.2022, resolved to inform KINFRA to pay 100% cost for carrying out the work.

Orders are issued accordingly.
