ORDER

The Chief Engineer, Distribution South, as per letter read as 2nd above requested sanction for effecting electricity connection to Smt Marykutty belonging to the BPL category under Electrical Section, Pattazhi, for her house constructed under the Life Mission Project. For effecting service connection to Smt Marykutty, construction of 325 m OH line is required (11 PSC poles) at an estimated cost of ₹1,37,940/-

As per the BO read as 1st above, BPL households with a maximum of 1000 W connected load shall be given free connection (WP with support posts / post insertion plus a maximum of 200 m OH), using the KSEBL fund, till the end of the plan period 2018-22 or till the fund of ₹50 Crores allotted for "continued electrification" in the plan fund for the period is exhausted, as long as there are no other specific schemes in place for granting electricity connections to BPL households free of cost.

The Chief Engineer requested sanction, since the OH portion to be drawn exceeds 200m. As per the letter read as 3rd above, the Deputy Chief Engineer, Electrical Circle, Kottarakkara has reported that the connected load of the applicant is 872 Watts.

As per OrumaNet records, the amounts utilized for effecting free connection to BPL households as per the BO read as 1st above has exceeded the fund of ₹50 Crores allotted for "continued electrification" in the plan fund for the period 2018-22.

The matter of effecting electricity connection to Smt Marykutty belonging to the BPL category under Electrical Section, Pattazhi, and with a connected load of 872 Watts for her house constructed under the Life Mission Project by drawing 325m OH line (at an estimated cost of ₹1,37,940/-) using KSEBL fund, was placed before the Full Time Directors for a decision.

Having considered the matter in detail, the Full Time Directors in the meeting held on 07/05/2021, resolved to accord sanction to the Chief Engineer (Distribution – South) for effecting electricity connection to Smt Marykutty, Shaji Bhavan, Pattazhi, under Electrical Section, Pattazhi, belonging to the BPL category, and with a connected load of 872 Watts for her house constructed under the Life Mission Project by drawing 325m OH line (at an estimated cost of ₹1,37,940/-) using KSEBL fund.
